**TRADEMARK ASSIGNMENT**

**THIS ASSIGNMENT** (this "Assignment") is made effective as of the date specified below, by and between Sola Custom Coatings, Inc., a Delaware corporation, with its principal place of business at 9117 S.E. St. Helens, Clackamas OR ("Assignor"), and Sola International Inc., a Delaware corporation, with its principal place of business at Torrey View Corporate Centre, 10590 West Ocean Air Drive, Suite 300, San Diego, CA 92130 ("Assignee").

**WHEREAS**, Assignor has adopted, used and owns the trademark CLEARLIGHT (the "Mark") on or in connection with coatings for optical lenses;

**WHEREAS**, Assignor has obtained a registration for the Mark on the Principal Register of the United States Patent and Trademark Office, for the above-identified goods in International Class 2, U.S. Registration No. 1,910,968, issued on August 15, 1995 (the "Registration"); and


**WHEREAS**, Assignee desires to acquire all rights, title and interest in and to the Mark and the Registration, including all of the goodwill associated with and symbolized by the Mark.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns and transfers the Mark and Registration to Assignee as follows:

1. Assignor hereby sells, assigns, and transfers to Assignee, its successors and assigns, all rights, title, and interests in and to the Mark, including all common law rights, together with all of the goodwill associated with and/or symbolized by the Mark.
2. Assignor hereby sells, assigns, and transfers to Assignee, its successors and assigns, all rights, title, and interests in and to the Registration, including all common law rights, together with all of the goodwill associated with and/or symbolized by the Registration.
3. Assignor hereby assigns to Assignee all causes of action, claims and rights to damages or profits, due or accrued, arising out of past infringement of the Mark, or injury to the goodwill associated with the Mark, as well as the rights to sue for and recover the Mark in Assignee's own name.
4. Assignor represents and warrants that it will cooperate in any actions necessary for Assignee to prosecute, renew or register its rights, title and interests in and to the Mark, including United States and foreign registrations, and to cooperate in any actions brought to enforce the rights accompanying this Assignment against third parties.
