**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is executed as of this 31 day of July, 2003, by BANK OF AMERICA, N.A., a national banking association (formerly Bank of America National Trust and Savings Association), in its capacity as collateral agent (the "Collateral Agent") for itself and each lender party to the Credit Agreement defined below (the "Lenders").

WHEREAS, Samsonite Corporation, a Delaware corporation (the "Domestic Borrower"), the Collateral Agent, Samsonite Europe N.V. ("Samsonite Europe") and certain lenders (the "Lenders") entered into that certain Second Amended and Restated Multicurrency Revolving Credit and Term Loan Agreement dated as of June 24, 1998 (as amended through the date hereof, the "Credit Agreement").

WHEREAS, in connection with the Credit Agreement, MCGREGOR II, LLC ("MCGREGOR") and the Collateral Agent entered into that certain Trademark Collateral Security and Pledge Agreement, dated as of August 7, 1998 (as may have been amended, modified, supplemented or restated from time to time, the "Security Agreement").

WHEREAS, pursuant to the terms and conditions of the Security Agreement and other loan documents, the Collateral Agent was granted a security interest in certain trade names, trademarks, and service marks, in any and all forms, including, but not limited to, those trade names, trademarks and service marks listed in attached Schedule A (the "Trademarks") for the benefit of itself and the Lenders.

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office at Reel 1767 Frame 0130 on August 10, 1998.

WHEREAS, the Collateral Agent has received consideration for a full and complete release of the security interest in and liens in the Trademark, and now wishes to release such security interest and liens in the Trademark.

NOW THEREFORE, the Collateral Agent represents and agrees as follows:

1. The Collateral Agent hereby releases, cancels and terminates its security interest in the entire right, title and interest in and any and all liens it may have on the Trademarks and the goodwill associated with such Trademarks, symbolized by such Trademarks, and all other rights with respect to the Trademarks.
2. The Collateral Agent represents and warrants that it has not exercised any of the rights with respect to the Trademarks available to it under its security interest. The Collateral Agent represents and warrants that it has not sold, licensed, conveyed or otherwise alienated any rights in and to the Trademarks, and that it has not used or sublicensed the Trademarks.
3. The Collateral Agent agrees that hereafter it will not take any action with respect to the Trademarks.

4. The Collateral Agent shall, at MCGREGOR's expense, take all further actions, and provide to MCGREGOR, its successors, assigns or other legal representatives, all such cooperation and assistance, including, without limitation, the execution and delivery of any and all documents or other instruments reasonably requested by MCGREGOR to more fully and effectively effectuate the purposes of this Release.

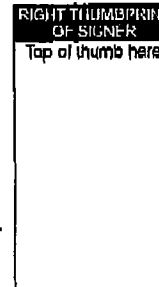
