RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL

This RELEASE, dated as of January 4, 2005, is made by AIGTI, INC., a Delaware corporation which was formerly known as AIG CAPITAL CORP. ("AIG"), as the holder of a promissory note, pursuant to the termination of the Note Purchase Agreement (the "Note"), by and among, AIG and THE COOPER COMPANIES, INC., a Delaware corporation (the "Pledgor").

WHEREAS, AIG acknowledges full payment, complete performance and satisfaction of all obligations pursuant to the Note secured by the Security Agreement have been made;

WHEREAS, AIG acknowledges full payment, performance and satisfaction of the conditions set forth in that certain payoff letter by and between AIG and the Pledgor, dated as of January 4, 2005; and

WHEREAS, the Pledgor has requested that AIG release its security interest in the Trademark Registrations, Associated Goodwill and Trademark Rights, as defined in the Security Agreement in connection with the termination of the Note and the Security Agreement (the "Released Collateral").

NOW, THEREFORE, in consideration of the foregoing, AIG hereby RELEASES all of its security interest in the Trademark Registrations listed on Schedule A attached hereto and incorporated herein by reference, Associated Goodwill, Trademark Rights and any other collateral described in the Security Agreement.

AIG agrees to provide the Pledgor with any information and additional authorization necessary to effect the release of its security interest in the Released Collateral.
