

TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT (this "Agreement") is made and entered into this _3ist day of August, 2004 by Scanbuy, Inc. (the "Grantor"), and Amalgamated Bank (the "Grantee") (each of the Grantor and Grantee, a "party" and, collectively, the "parties"). Capitalized terms used herein but not otherwise defined herein shall have the meanings set forth in the Accounts Receivable Security Agreement, dated as of July 14, 2003, between Grantor and Grantee, and all Riders thereto, as amended, supplemented or otherwise modified from time to time (the "Security Agreement").

WHEREAS, the Grantor is justly indebted, liable and obligated to the Grantee pursuant to that certain Promissory Note, dated as of July 10, 2003 (as amended, supplemented or otherwise modified from time to time), among the Grantor and the Grantee;

WHEREAS, the Grantor and the Grantee have entered into the Security Agreement pursuant to which the Grantor has granted to the Grantee a lien on and security interest in, inter alia, all of the Grantor's rights, title, and interest in and to all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos and other source or business identifiers, certain prints or labels on which any of the foregoing appear, and all designs and general intangibles of a like nature, and the goodwill associated therewith or symbolized thereby, and all other assets, rights and interests that uniquely embody such goodwill, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any state thereof or any other country or any political subdivision thereof, or otherwise, including, without limitation, any thereof referred to in Schedule A hereto, and (b) all extensions or renewals thereof (collectively the "Trademarks") of such Grantor;

WHEREAS, the parties desire to record the Grantor's grant of the security interest in the Trademarks to the Grantee with the United States Patent and Trademark Office:

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

- 1. Grant of Security Interest. The Grantor has agreed to give this Agreement as security for the Trademarks and has authorized and directed the execution and delivery hereof, and all of Grantor's right, title and interest in and to the Trademarks and all proceeds thereof, including all rights therein provided by international conventions and treaties, and the right to sue for past, present and future infringement thereof.
- 2. <u>Further Assurances</u>. Grantor shall, at the cost and expense of Grantor, timely execute and deliver any additional documents and perform such additional acts necessary or desirable to permit Grantee to record and perfect the interest of Grantee in and to the Trademarks, including, without limitation, executing before a notary public the applicable assignment documents. Grantor shall not enter into any agreement in conflict with this Agreement.

- 3. <u>Rights and Remedies</u>. Grantor further acknowledges and affirms that the rights and remedies of the Grantee with respect to the Trademarks are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated by reference as if fully set forth herein.
- 4. <u>Governing Law</u>. This Agreement shall be governed by and construed in accordance with the laws of the State of New York, without regard to the conflicts of law rules of such state.
- 5. <u>Counterparts</u>. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same agreement.
