

PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

In witness whereof, Lender has caused this Partial Release of Security Interest in Trademarks to be executed by its duly authorized corporate officer this 9 date of February, 2005.

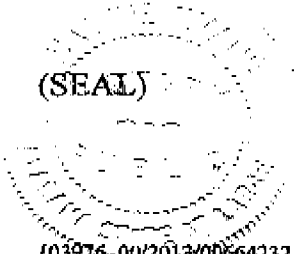
