Assignment of Trademarks

FOR GOOD AND VALUABLE CONSIDERATION the receipt and sufficiency of which are hereby acknowledged, effective as of the 23rd day of February 2005 (the "Transfer Date"), Novartis AG Corporation, a Swiss corporation having an address at CH-4002, Basel, Switzerland ("Assignor"), assigns to Unilens Corp. USA, a Delaware corporation having offices at 10431 72nd Street North; Largo, Florida 33777 ("Assignee") the following (collectively, the "Assigned Property"):

- 1) All rights, titles and interest in the marks set forth in Exhibit A attached hereto and incorporated herein by this reference, the goodwill of the business symbolized by said marks, and all registrations thereof as set forth in Exhibit A (collectively, the "Marks")

Furthermore, as of the Transfer Date, Assignor represents and warrants to Assignee that:

- 1) Assignor is the exclusive owner of the Assigned Property and has the right to assign the Assigned Property to Assignee;
- 2) Neither Assignor nor any person or legal entity controlling, controlled by, or under common control with Assignor (an "Affiliate") has assigned, licensed, or conveyed any rights or interest in the Marks that are, or could be, inconsistent with the rights granted to Buyer hereunder;
- 3) To the knowledge of Assignor, no third party is violating or infringing on the Marks;
- 4) The execution, delivery, and performance of this Assignment and the consummation of the transactions contemplated hereby have been duly and validly authorized by all necessary corporate action of the part of the Assignor, and this Assignment has been duly and validly executed and delivered and constitutes the legal, valid, and binding obligation of the Assignor, enforceable in accordance with its term;
- 5) The Assignor has good and marketable title to the Assigned Property, free and clear of any claims of third parties;
- 6) To Assignor's knowledge, there are no pending or threatened legal actions, claims, or proceedings against Assignor that relate, directly or indirectly, to the Assets; and

- 7) Assignor is now, and has heretofore been, in compliance with all applicable laws, rules, regulations, orders, and judgments of any governmental authorities applicable to the Assigned Property and has undertaken all action in accordance therewith required to be taken in connection with the assignment of the Assigned Property, including, without limitation, obtaining the authorization, consent, and approval of all relevant governmental entities.

At the request of the Assignee, Assignor will take all other action necessary or appropriate for the further assurance of the assignment of the Assigned Property by Assignor to Assignee including, without limitation, the execution of additional assignments relating to the assignment of the Marks as required by the applicable jurisdiction for registration and assignment.
