**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. The Assignor hereby sells, assigns, transfers, conveys and sets over to Assignee and its successors, assigns and nominees absolutely and forever, the entire right, title and interest in and to all of the Marks together with the goodwill of the Business associated therewith.

2. The Assignor hereby authorizes Assignee to request the relevant Trademark Offices to record the Assignee as the assignee and owner of the Marks.

3. This Assignment is effective as of the Effective Date. The Assignor shall, without further consideration, comply with any reasonable request by Assignee to execute and deliver promptly any additional documents as may be necessary in order to give effect to the assignment of rights reflected herein.

4. Subject to any applicable legislation, the parties agree that the assignment of each Mark on Exhibit A, Exhibit B and Exhibit C shall be construed as separable and divisible from the assignment of every other Mark. The unenforceability or invalidity of this Assignment with respect to any one Mark shall not limit its enforceability or validity, in whole or in part, with respect to any other Mark.

5. This Assignment, together with the Agreement, represents the entire agreement between the parties with respect to the ownership and assignment of the Marks, and supercedes any and all prior agreements, understandings and communications between the parties, whether oral or written, with respect thereto.

6. The Assignee appoints Davies Ward Phillips & Vineberg LLP, whose full postal address in Canada is 1501 McGill College Avenue, 26<sup>th</sup> Floor, Montreal, Quebec H3A 3N9, as the firm to whom notice in respect of the Marks may be given or served with the same effect as if they had been given or served upon it.
