U.S. TRADEMARKS RELEASE OF SECURITY INTEREST

THIS RELEASE dated as of March 31, 2005, by Bank of America, N.A., formerly known as Bank of America National Trust and Savings Association (the "*Bank*"). Terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement referred to below.

A. Reference is made to the Credit Agreement dated as of October 31, 1995, as amended and restated by the Business Loan Agreement, dated as of November 1, 2002 (as amended from time to time, the "*Credit Agreement*"), among Athletics Investment Group LLC, a California limited liability company (the "*Borrower*"), the lenders party thereto and the Bank.

B. Reference is made to (i) the Security Agreement, dated as of October 31, 1995 (the "*Security Agreement*"), among the Grantors (as defined in the Security Agreement) in favor of the Bank and (ii) the Trademark and License Security Agreement dated as of October 31, 1995 (the "*Trademark Security Agreement*"), made by the Grantors in favor of the Bank, pursuant to which, among other things, the Grantors granted a security interest to the Bank in, among other things, the registered trademarks of the Grantors as set forth on Annex I hereto (the "*Trademarks*"), which security interest was recorded with the United States Patent & Trademark Office against certain trademarks at Reel 1408 Frame 0597 on November 3, 1995.

C. In connection with the termination of the Credit Agreement, the Borrower has informed the Bank of its desire to obtain the release of all right, title and interest of the Bank and each other grantee or beneficiary in and to the Trademarks granted under the Security Agreement and the Trademark Security Agreement.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, all the Bank's right, title and interest (including, without limitation, security interests) in and to the Trademarks pursuant to the Security Agreement and the Trademark Security Agreement shall automatically terminate as provided in the Security Agreement and the Trademark Security Agreement, including, without limitation, the Trademarks set forth on Annex I attached hereto, the debt secured thereby having been paid and satisfied in full.
