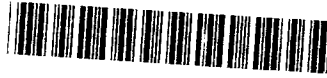

**TRADEMARK RELEASE**

This Release granted on this 20<sup>th</sup> day of April, 2004, by Deutsche Bank Trust Company Americas, (f.k.a. Bankers Trust Company) as Collateral Agent ("Assignee") to Cabot Safety Intermediate Corporation, a Delaware corporation with principal offices at 650 Dawson Drive, Newark, DE 19713 ("Assignor"), as follows:

**WITNESSETH**

WHEREAS, the Assignor has heretofore assigned and granted to the Assignee a security interest in certain U.S. trademarks, trademark registrations and trademark applications as more particularly set forth on Schedule A attached hereto (the "Marks") to secure the Obligations as defined in the Security Agreement, dated as of July 11, 1995 and restated as of July 13, 2001 (as amended from time to time, the "Security Agreement"), between the Assignee, the Assignor, and the other assignors from time to time party thereto; and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Assignee hereby releases, discharges, quit claims and relinquishes unto the Assignor any and all right, title and interest in and to the Marks, and more particularly, the security interest in (i) the trademarks, trademark registrations and trademark applications as set forth on Schedule A hereto, (ii) all Proceeds (as such term is defined in the Security Agreement referred to above) and products of the Marks, (iii) the goodwill of the businesses symbolized by the Marks and (iv) all causes of action arising prior to or after the date of the earliest assignment and grant hereunder for infringement of any of the Marks or unfair competition regarding the same, and granted to the Assignee by the Assignor by the Security Agreement, which assignment was duly recorded on August 20, 2001 at Reel 2351, Frame 0431 in the United States Patent and Trademark Office.
