

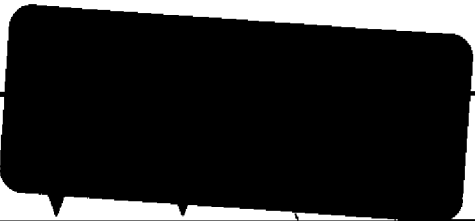

## 2. ASSET TRANSFER

On the terms and subject to the conditions set forth herein, the Seller shall, with effect from the Closing Date, sell, transfer, assign and deliver, or cause the Company to sell, transfer, assign and deliver, all of its right, title and interest in the Transferred Assets to the Buyer, and the Buyer shall purchase and acquire all the right, title and interest to the Transferred Assets, with all risk of loss and damage to pass with title, for a total of States Dollars (US\$ 1) (the "Purchase Price"). The Purchase Price shall be paid by the Buyer by wire transfer of immediately available funds to an account specified by the Seller on July 31, 2003 (unless the Buyer and Seller agree in writing to a different method of payment).

#### 4.2 THINK Brand and Trademarks

For purposes of this Section 4.2, Seller's knowledge shall mean the knowledge of the members of the trademark group of the Seller's wholly-owned subsidiary, Ford Global Technologies, Inc., located in Dearborn, Michigan and not otherwise.

To the best of Seller's knowledge, Seller represents that Schedule 1 is true and correct and is a complete and accurate list of all THINK Brand and Trademarks.

To the best of Seller's knowledge, Seller represents that Schedule 5 is true and correct and is a complete and accurate list of the pending conflicts relating to the THINK Brand and Trademarks. Except as disclosed on Schedule 5, to the best of Seller's knowledge, the THINK Brand and Trademarks have not been infringed by any Third Party.

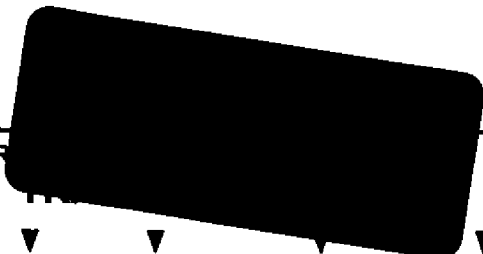
