GRANT OF SECURITY INTEREST

TRADEMARKS

THIS GRANT OF SECURITY INTEREST, dated as of June 8, 2005, is executed by CHIEF MANUFACTURING, INC., a Massachusetts corporation ("CMI"), and DECADE INDUSTRIES, INC. (DBA SANUS SYSTEMS), a Minnesota corporation ("Sanus"), in favor of WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, as Administrative Agent for the Lenders referenced below ("Administrative Agent").

A. Pursuant to that certain Credit Agreement, dated as of even date herewith (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among CMI, Sanus, Chief Manufacturing Holding Corp., a Delaware corporation ("Parent"), Wells Fargo Bank, National Association, as L/C Issuer, Swing Line Lender and Administrative Agent, and each of the lenders party thereto from time to time (the "Lenders"), the Lenders have agreed to extend certain credit facilities to the Borrowers upon the terms and subject to the conditions set forth therein (the "Credit Facility").

B. CMI and Sanus have adopted, used and are using the trademarks, more particularly described on Schedules 1-A and 1-B annexed hereto and made a part hereof, which trademarks are registered or subject to an application for registration in the United States Patent and Trademark Office (collectively, the "Trademarks").

C. CMI and Sanus have entered into a Security Agreement (Intellectual Property) dated as of the date hereof (the "IP Security Agreement") with Administrative Agent on behalf of the Lenders.

D. Pursuant to the IP Security Agreement, CMI and Sanus have granted to Administrative Agent on behalf of the Lenders a security interest in all right, title and interest of CMI and Sanus in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the customer lists and records related to the Trademarks and the applications and registrations thereof, and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof (the "Collateral"), to secure the payment, performance and observance of the Secured Obligations, as defined in the IP Security Agreement.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, CMI and Sanus do hereby further grant to the Administrative Agent on behalf of the Lenders a security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.

CMI and Sanus do hereby further acknowledge and affirm that the rights and remedies of Administrative Agent with respect to the security interest in the Collateral granted hereby are more fully set forth in the IP Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

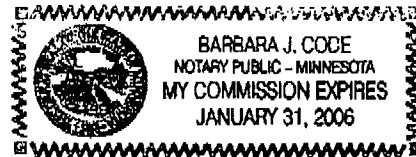
