THIS TRADEMARK AND COPYRIGHT SECURITY ASSIGNMENT AGREEMENT (this "Agreement"), dated as of this 3rd day of June, 2005, between SYRATECH CORPORATION, a Delaware corporation ("Assignor"), and U.S. BANK NATIONAL ASSOCIATION, as Trustee, for the benefit of itself and the holders of the Convertible Senior Notes Due 2010 ("Assignee").

This Agreement acts as a supplement to that certain Security Agreement (as amended, supplemented or modified from time to time, the "Security Agreement"), dated as of June 3, 2005 among Assignor, each of WALLACE INTERNATIONAL DE P.R., INC., a Delaware corporation and CHI INTERNATIONAL, INC., a Maryland corporation.

NOW, THEREFORE, the parties hereto, intending to be legally bound, hereby agree as follows:

### 1. DEFINED TERMS

Capitalized terms used herein and not otherwise defined shall have the meanings ascribed to them in the Security Agreement. As used herein, the plural includes the singular and the singular includes the plural. The following additional terms, as used herein, have the following respective meanings:

"Copyright" means any material protected under state or federal copyright law.

"Copyright License" means any agreement now or hereafter in existence granting to Assignor any rights related to any Copyright.

"Patents" means all of the following: (i) all letters patent of the United States or any other country, all registrations and recordings thereof, and all applications for letters patent of the United States or any other country including, without limitation, registrations, recordings and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any state thereof or any other country or any political subdivision thereof, and (ii) all reissues, continuations, continuations-in-part, divisions or extensions thereof.

"<u>Patent License</u>" means any written agreement now or hereafter in existence granting to Assignor any right to practice any invention on which a Patent is in existence.

"Trademarks" means all of the following: (i) all trademarks listed in Schedule A, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos, other source or business identifiers, prints and labels on which any of the foregoing have appeared or appear, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith including, without limitation, registrations, recordings, and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any state thereof or any other country or any political subdivision thereof; (ii) all renewals thereof; (iii) all goodwill of the business symbolized by such trademarks; and (iv) that portion of any Assignor's business pertaining to said trademarks, which businesses are ongoing and existing.

"<u>Trademark License</u>" means any written agreement now or hereafter in existence granting to Assignor any right to use any Trademark.

### 2. REPRESENTATIONS AND WARRANTIES

Assignor represents and warrants as follows: (i) Assignor owns the Trademarks as set forth in the attached Schedule A; (ii) the Trademarks as set forth in Schedule A are the only Trademarks to which Assignor has title or rights; (iii) Assignor owns the Copyrights as set forth in the attached Schedule B; (iv) the Copyrights as set forth in Schedule B are the only Copyrights to which Assignor has title or rights; and (v) Assignor has no rights to any Patents.

### 3. THE LIEN

Assignor hereby grants to Assignee for the benefit of Assignee and the holders of the Senior Notes a continuing security interest and lien in and to the Trademarks and Copyrights of Assignor, whether now owned or existing or hereafter acquired by or arising in favor of Assignor (collectively the "Collateral").

### COVENANT

Assignor shall notify Assignee immediately (i) of any acquisition after the date hereof of any registered Copyrights, Copyright Licenses, Patents, Patent Licenses, Trademarks or Trademark Licenses and (ii) if Assignor knows, or has reason to know, that any application or registration relating to any Copyrights, Patents or Trademarks may become abandoned, or if any adverse determination or development (including, without limitation, the institution of any proceeding in the Unites States Patent or Trademark Office, United States Copyright Office or any court), regarding Assignor's ownership of any Copyrights, Patents or Trademarks, the right to register the same, or to keep and maintain the same. In the event that any Copyright, Copyright License, Patent, Patent License, Trademark or Trademark License is infringed, misappropriated or diluted by a third party, Assignor shall notify Assignee promptly after Assignor learns thereof and shall, unless Assignor shall reasonably determine that any such action would be of negligible economic value, promptly sue for infringement, misappropriation, or dilution and to recover any and all damages for such infringement, misappropriation or dilution, and take such other actions as Assignor shall reasonably deem appropriate under the circumstances to protect such Copyright, Copyright License, Patent, Patent License, Trademark or Trademark License. In no event shall Assignor, either itself or through any Subsidiary, agent, employee or licensee, file an application for the registration of any Copyright, Patent or Trademark with the United States Patent and Trademark Office, the United States Copyright Office or any similar office or agency in any other country or any political subdivision thereof, unless not less than 30 days prior thereto they inform Assignee, and, upon request of Assignee. execute and deliver any and all agreements, instruments, documents and papers Assignee may request to evidence the Lien in such Copyright, Patent or Trademark and the goodwill and general intangibles of Assignor relating thereto or represented thereby, and Assignor hereby constitutes and appoints Assignee its attorney-in-fact to execute and file all such writings for the foregoing purposes, all acts of such attorney being hereby ratified and confirmed and such power, being coupled with an interest, shall be irrevocable until the Obligations are indefeasibly paid in full.

### 5. REMEDIES UPON EVENT OF DEFAULT

Without limiting the generality of the foregoing, if any Event of Default has occurred and is continuing:

- (i) Assignee may license, or sublicense, whether on an exclusive or nonexclusive basis, any Copyrights, Patents or Trademarks throughout the world for such term or terms, on such conditions and in such manner as Assignee shall in its sole discretion determine;
- (ii) Assignee may (without assuming any obligations or liability thereunder), at any time and from time to time, enforce (and shall have the exclusive right to enforce) against any licensee or sublicense, or against any infringer, all rights and remedies of Assignor in, to and under any Copyright Licenses, Patent Licenses or Trademark Licenses (including the right to sue for both past and present damages for infringement, and the rights to collect royalties under all Patent, Trademark and Copyright Licenses), and take or refrain from taking any action under any thereof, and Assignor hereby releases Assignee from, and agrees to hold Assignee free and harmless from and against any claims arising out of, any lawful action so taken or omitted to be taken with respect thereof; and
- (iii) Upon request by Assignee, Assignor will execute and deliver to Assignee a power of attorney, in form and substance satisfactory to Assignee, for the implementation of any lease, assignment, license, sublicense, sale or other disposition of a Copyright, Patent or Trademark. In the event of any such disposition pursuant to this Section, Assignor shall supply their know-how and expertise relating to the manufacture and sale of the products bearing Trademarks or the products or services made or rendered in connections with Patents, or the products or services made or rendered in connection with Copyrights, and its customer lists and other records relating to such Copyrights, Patents or Trademarks and to the distribution of said products to Assignee.

### 6. <u>SUBORDINATION OF LIEN</u>

Notwithstanding anything herein to the contrary, the security interest and lien in the Collateral grated to the Assignee hereunder shall be subordinate and junior to the security interest and lien in the Collateral granted to CapitalSource Finance LLC or any replacement revolving credit lender ("CapitalSource") in accordance with the terms of that certain Intercreditor Agreement, dated the date hereof, between the Secured Party and CapitalSource (the "Intercreditor Agreement"). The Secured Party hereby agrees that it shall not take any action under Section 5 hereof without the consent of CapitalSource while such Intercreditor Agreement remains in full force and effect. To the extent any of the terms herein are inconsistent with the terms of the Intercreditor Agreement, the Intercreditor Agreement shall control.
