GOLD RIVER MILLS, LLC, Limited Liability Company and PACIFIC BASIN RICE PRODUCTS, LLC Limited Liability Company (individually, an "LLC", and collectively, the "LLCs") hereby certify that:

FIRST: The LLCs agree to merge.

SECOND: The name, place of organization, and Secretary of State's file numbers of each of the parties to the merger are:

(1) GOLD RIVER MILLS, LLC, Limited Liability Company, organized under the laws of California, Secretary of State File Number 200116910096.

(2) PACIFIC BASIN RICE PRODUCTS, LLC, Limited Liability Company, organized under the laws of California, Secretary of State File Number 200032610066.

THIRD: The name of the successor is GOLD RIVER MILLS, LLC which was organized under the laws of the State of California.

FOURTH: The principal office of GOLD RIVER MILLS, LLC in the State of California is P. O. Box 8729, Woodland, CA 95776. The principal office of PACIFIC BASIN RICE PRODUCTS, LLC in the State of California is P. O. Box 1815, Woodland, CA 95776.

FIFTH: The effective date of this merger is January 1, 2003.

SIXTH: GOLD RIVER MILLS, LLC owns an interest in land in Arbuckle, Colusa County, California and PACIFIC BASIN RICE PRODUCTS, LLC owns an interest in land in Woodland, Yolo County, California.

SEVENTH: The terms and conditions of the merger were advised, authorized and approved by the Members of each LLC by the requisite Vote of its Members as set forth in its Operating Agreement.

EIGHTH: No amendment to the Articles of Organization of the successor LLC, GOLD RIVER MILLS, LLC Limited Liability Company, is required on account of the merger.

NINTH: Prior to the merger, the percentage of interests of each class of interest in each LLC was:


- (1) GOLD RIVER MILLS, LLC -- one class 100%
- (2) PACIFIC BASIN RICE PRODUCTS, LLC - one class 100%

TENTH: The manner and basis of converting the outstanding interests of each LLC into interests of the successor LLC are as follows:

A one percent interest in GOLD RIVER MILLS, LLC Limited Liability Company as it exists immediately prior to the merger will become a .558% interest in GOLD RIVER MILLS, LLC Limited Liability Company on the effective date of the merger. A one percent interest in PACIFIC BASIN RICE PRODUCTS, LLC Limited Liability Company as it exists immediately prior to the merger will become a .955% interest in GOLD RIVER MILLS, LLC Limited Liability Company on the effective date of the merger.


