RELEASE OF SECURITY AGREEMENT

THIS RELEASE dated as of June 17, 2005 (this "Release") is made by Credit Suisse, Cayman Islands Branch (formerly Credit Suisse First Boston, Cayman Islands Branch), acting in its capacity as Administrative Agent for the Secured Parties (in such capacity, the "Administrative Agent") under that certain Trademark Security Agreement, dated December 9, 2003 and recorded in the records of the United States Patent and Trademark Office on December 25, 2003 at Reel 002893, Frame 0482 (as amended, supplemented or modified and in effect from time to time, the "Security Agreement"), between Transworld Systems Inc., a California Corporation, OSI Support Services, Inc., a Wisconsin corporation (each a "Grantor", and collectively, the "Grantors") and the Administrative Agent. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

W I T N E S S E T H:

SECTION 1. WHEREAS, pursuant to the Security Agreement, each Grantor, as security for the payment and performance in full of all the Secured Obligations, mortgaged, pledged and hypothecated to the Administrative Agent, and granted to the Administrative Agent a security interest in, for its benefit and the benefit of each Secured Party, all of the following property (the "Trademark Collateral"):

(a) (i) all of its Trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, certification marks, collective marks, logos and other source or business identifiers, and all goodwill of the business associated therewith, including those referred to in Item A of Schedule I hereto, whether currently in use or not, all registrations and recordings thereof and all applications in connection therewith, whether pending or in preparation for filing, including registrations, recordings and applications in the United States Patent and Trademark Office or in any office or agency of the United States of America or any State thereof or any other country or political subdivision thereof or otherwise, and all common-law rights relating to the foregoing, and (ii) the right to obtain all reissues, extensions or renewals of the foregoing (collectively referred to as the "Trademark");

(b) all Trademark licenses for the grant by or to such Grantor of any right to use any Trademark, including each Trademark license referred to in Item B of Schedule I hereto;

(c) all of the goodwill of the business connected with the use of, and symbolized by the items described in, clause (a), and to the extent applicable clause (b);

(d) the right to sue third parties for past, present and future infringements of any Trademark Collateral described in clause (a) and, to the extent applicable, clause (b); and

(e) all Proceeds of, and rights associated with, the foregoing, including any claim by such Grantor against third parties for past, present or future infringement or dilution of any Trademark, Trademark registration or Trademark license, or for any injury to the goodwill associated with the use of any such Trademark or for breach or enforcement of any Trademark license and all rights corresponding thereto throughout the world.

WHEREAS, the Administrative Agent wishes to: (i) terminate the Security Agreement against the Trademark Collateral, including those Trademarks identified in Schedule I hereto recorded with the United States Patent and Trademark Office; (ii) release all of its security interest covering the Trademark Collateral, including those Trademarks listed in Schedule I hereto; and (iii) to dissolve any and all liens and encumbrances respecting the Trademark Collateral including those Trademarks listed in Schedule I hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby release its security interest in the Trademark Collateral, including those Trademarks set forth on Schedule I hereto, and discharges, quit claims and relinquishes unto the Grantor, (in each case without recourse and without any representation or warranty) any and all rights, title and interest it has in, and the security interest granted to the Administrative Agent in, the Trademark Collateral, including those Trademarks listed in Schedule I hereto.

IN WITNESS WHEREOF, the Administrative Agent has caused this Release to be duly executed and delivered by its officer thereunto duly authorized as of the day and year first above written.
