

CERTIFICATE OF AMENDMENT

OF

ARTICLES OF INCORPORATION

OF

ADVANTECH AUTOMATION CORPORATION

KE-CHENG LIU and LUCIA WANG certify that:

- They are the President and Secretary, respectively, of ADVANTECH AUTOMATION CORPORATION, a California corporation.
- 2 Article of the Articles of Incorporation is hereby stricken and amended to read as follows:

"The name of this corporation is Advantech Corporation."

- 3. Article III of the Articles of Incorporation is hereby stricken and amended to read as follows:
 - "The corporation is authorized to issue only one class of shares, which shall be designated common shares. The total number of shares which the corporation is authorized to issue is fifteen million (15,000,000) common shares.
- The foregoing amendments of Articles of Incorporation have been duly approved by unanimous written consent of the Board of Directors in accordance with Section 307(b) of the Corporations Code.
- 5. The foregoing amendments of Articles of Incorporation have also been duly approved by the required vote of shareholders in accordance with Section 902 of the Corporations Code. The corporation has only one class of shares, and the total number of outstanding common shares is four million five hundred sixty-seven thousand four hundred (4,567,400). The amendments were approved by the vote of a number of shares which equals or exceeded the vote required. The percentage vote required was more than 50 percent.
