ASSIGNOR hereby agrees to communicate to Assignee or to its successors, assigns or legal representatives any and all facts known to it respecting the Marks, and without further remuneration to testify in any legal proceeding, sign all lawful papers, make all rightful oaths, and generally do all lawful acts to aid Assignee or its successor, assigns or legal representatives to obtain and enforce proper trademark protection for the Marks in all countries and to enhance or perfect Assignee's title in and to the Marks therein.
