## Trademark Security Agreement

Trademark Security Agreement, dated as of June 13, 2005, by COLIBRI CORPORATION (the "Pledgor"), a wholly owned subsidiary of The Colibri Group, Inc. (the "Corporation"), in favor of HSBC BANK USA, NATIONAL ASSOCIATION (the "Administrative Agent") for the benefit of the Agents, Issuer and Lenders parties to that certain Consignment and Loan Agreement with the Corporation of even date (the "Credit Agreement").

### WITNESSETH:

WHEREAS, Pledgor is party to a Continuing General Security Agreement of even date herewith (the "Security Agreement") in favor of the Administrative Agent for the benefit of the Agents, Issuer and Lenders pursuant to which the Pledgor is required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Administrative Agent for the benefit of the Agents, Issuer and Lenders to accept the Security Agreement, the Pledgor hereby agrees with the Administrative Agent as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

SECTION 2. Grant of Security Interest in Trademark Collateral. Pledgor hereby pledges and grants to the Administrative Agent for the benefit of the Agents, Issuer and Lenders a lien on and security interest in and to all of its right, title and interest in, to and under all the following Pledged Collateral of such Pledgor:

- (a) Trademarks of Pledgor listed on Schedule I attached hereto;
- (b) all business goodwill associated with such Trademarks; and
- (c) all Proceeds of any and all of the foregoing.

SECTION 3. Security Agreement. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Administrative Agent for the benefit of the Agents, Issuer and Lenders pursuant to the Security Agreement and Pledgor hereby acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademarks made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.


**SECTION 4. Termination.** Upon the full performance of the Obligations, the Administrative Agent (for the benefit of the Agents, Issuer and Lenders) shall execute, acknowledge, and deliver to the Pledgor an instrument in writing in recordable form releasing all collateral pledges, grants, liens and security interests in the Trademarks under this Trademark Security Agreement.

This Trademark Security Agreement may be executed in any number of separate counterparts, and all of said counterparts taken together shall be deemed to constitute one and the same instrument. Delivery of an executed counterpart of this Trademark Security Agreement by telecopier or electronic transmission shall be effective as delivery of a manually executed counterpart of this Trademark Security Agreement.


