FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT

THIS FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT ("Amendment"), dated as of July 7, 2005, is executed and delivered by BIG DOG USA, INC., a California corporation ("Big Dog"), BIG DOG HOLDINGS, INC., a Delaware corporation ("Parent," and together with Big Dog, individually and collectively, the "Grantors"), in favor of WELLS FARGO RETAIL FINANCE II, LLC, a Delaware limited liability company, as arranger and administrative agent for the Lender Group (defined herein) (in such capacity, together with its successors, if any, in such capacity, "Agent").

WHEREAS, Grantors and Agent are parties to that certain Trademark Security Agreement, dated as of October 23, 2001 (as hereby amended, the "Trademark Security Agreement");

WHEREAS, the Agent and Grantors are parties to that certain Loan and Security Agreement, dated as of October 23, 2001 (as amended, the "Big Dog Agreement"), between and among Grantors, the lenders party thereto (the "Big Dog Lenders"), and the Agent, as arranger and administrative agent for the Big Dog Lenders;

WHEREAS, the Agent is also party to that certain Loan and Security Agreement, dated as of March 3, 2004, (as amended, the "TWC Agreement") between and among The Walking Company ("TWC" f/k/a TWC Acquisition Corp.), the lenders party thereto (the "TWC Lenders"), and the Agent, as arranger and administrative agent for the TWC Lenders;

WHEREAS, Parent has executed that certain General Continuing Guaranty, dated as of October 23, 2001, in favor of Agent (the "Guaranty");

WHEREAS, Big Dog and TWC are wholly owned subsidiaries of Parent;

WHEREAS, TWC and Big Dog (individually and collectively, the "Borrowers"), Parent, the Big Dog Lenders and the TWC Lenders (collectively, the "Lenders"), and the Agent (Agent and the Lenders, individually and collectively, the "Lender Group") desire to amend, restate, and consolidate the Big Dog Agreement and the TWC Agreement into a single agreement under which the Borrowers are co-Borrowers;

WHEREAS, in furtherance of the foregoing, Borrowers, Parent, and the Lender Group are, contemporaneously herewith, entering into that certain First Amended, Restated and Consolidated Loan and Security Agreement (as it may be subsequently amended, restated, modified or supplemented, the "Loan Agreement");

WHEREAS, as a condition to Agent and Lenders agreeing to consolidate, amend and restate the Big Dog Agreement and the TWC Agreement into a single agreement, Agent and Lenders have required the Parent to amend and restate the Guaranty to clarify that Parent is guarantying the Obligations of each Borrower under the Loan Agreement (as defined therein) and have required Grantors to amend the Trademark Security Agreement so that it secures all of the Obligations of each Borrower owing to the Lender Group under the Loan Agreement (as defined therein);

WHEREAS, in order to induce the Lender Group to enter into the Loan Agreement, and in consideration thereof, and in consideration of any loans or other financial accommodations heretofore or hereafter extended by the Lender Group to Borrowers, whether pursuant to the Loan Agreement or otherwise, Grantors have agreed to amend and ratify the Trademark Security Agreement;

NOW THEREFORE, the Agent and Grantors agree as follows:

- 1. Amendment to Trademark Security Agreement.
- (a) Grantors and Agent acknowledge and agree that (i) all references to "Loan Agreement" in the Trademark Security Agreement shall mean "Loan Agreement" as defined herein, (ii) all references to "Borrowers" in the Trademark Security Agreement shall mean "Borrowers" as defined herein, (iii) all references to "Lenders" in the Trademark Security Agreement shall mean "Lenders" as defined herein, (iv) all references to "Lender Group" in the Trademark Security Agreement shall mean the "Lender Group" as defined herein, (v) all references to "Debtors" in the Trademark Security Agreement shall mean "Grantors" as defined herein; (vi) all references to "Secured Party" shall mean the "Agent" as defined in the Loan Agreement (defined herein); and (vii) all references to "Obligations" in the Trademark Security Agreement shall mean "Obligations" as defined in the Loan Agreement (defined herein).
- (b) Grantors hereby agree that the Trademark Collateral (as defined in the Trademark Security Agreement) shall secure all of the Obligations (as defined in the Loan Agreement) of each Borrower owing to the Lender Group under the Loan Agreement and that liens and security interests granted to the Secured Party in the Trademark Collateral pursuant to the Trademark Security Agreement are hereby granted to Agent.
- (c) Section 1(a) is hereby amended by adding the definition of "Obligations" as follows: "Obligations" shall have the meaning set forth in the Loan Agreement. Section 1(a) is hereby further amended by striking the words, "State of California" in the definition of "UCC" and replacing them with the words, "Commonwealth of Massachusetts."
- (d) <u>Schedule A</u> is deleted in its entirety and is replaced with <u>Schedule A</u> attached hereto.
- (e) Section 12 is hereby amended by striking the words, "State of California" in the clause, "the laws of the State of California," and replacing them with the words, "Commonwealth of Massachusetts." Section 12 is hereby further amended by striking the word, "California," in the last clause of the sentence, and replacing it with the word, "Massachusetts."
- 2. <u>Ratification</u>. The Loan Agreement and the performance or consummation of any transaction or matter contemplated under the Loan Agreement, shall not limit, restrict, extinguish or otherwise impair Grantors' liability to Agent and Lenders with respect to the obligations of Grantors pursuant to the Trademark Security Agreement. Grantors hereby ratify, confirm and approve the Trademark Security Agreement and acknowledge that they are unconditionally liable to Agent and Lenders for their obligations under the Trademark Security Agreement, which include, but are not limited to, securing the Obligations as defined in the Loan Agreement.

- 3. <u>Continuous Nature of Representations and Warranties</u>. Grantors represent that each representation and warranty set forth in the Trademark Security Agreement remains accurate, complete and not misleading in any material respect on the date hereof, except, in each case, for representations and warranties that explicitly relate to an earlier date.
- 4. <u>Effect of Amendment</u>. All the terms, conditions, and provisions of the Trademark Security Agreement, as amended, shall continue in full force and effect.
- 5. <u>Counterparts</u>. This Amendment may be executed in any number of counterparts, which together shall constitute one and the same agreement.
- 6. <u>Miscellaneous</u>. This Amendment and the Trademark Security Agreement constitute the entire agreement between the parties with respect to the subject matter hereof and supersede all prior dealings, correspondence, conversations or communications between the parties with respect to the subject matter hereof.
