AMENDED & RESTATED FIRST LIEN TRADEMARK SECURITY AGREEMENT

AMENDED & RESTATED FIRST LIEN TRADEMARK SECURITY AGREEMENT dated as of May 31, 2005 (as further amended, restated, supplemented or otherwise modified, the "Trademark Security Agreement"), made by ALM MEDIA HOLDINGS, INC., a Delaware corporation ("Holdings") and ALM PROPERTIES, INC., a Delaware corporation (collectively, the "Grantors"), in favor of GENERAL ELECTRIC CAPITAL CORPORATION ("GECC"), as collateral agent (in such capacity and together with its successors, the "Collateral Agent") for (i) the banks and other financial institutions or entities (the "Lenders") from time to time parties to the First Lien Credit Agreement dated as of March 7, 2005 (as amended, restated, supplemented or otherwise modified from time to time, the "First Lien Credit Agreement"), among Holdings, ALM Media, Inc., a Delaware corporation, the Lenders party thereto, Credit Suisse First Boston, as joint bookrunner, joint lead arranger and co-syndication agent, UBS Securities LLC, as joint bookrunner, joint lead arranger and co-syndication agent, GECC, as administrative agent and Collateral Agent, and Wells Fargo Foothill, Inc., as documentation agent, and (ii) the other Secured Parties.

WITNESSETH:

WHEREAS, Grantors are party to a First Lien Guarantee and Collateral Agreement dated as of March 7, 2005 (the "Guarantee and Collateral Agreement") between each of the Grantors and the other grantors party thereto and the Collateral Agent pursuant to which the Grantors were required to execute and deliver and did execute and deliver, a Trademark Security Agreement dated as of March 7, 2005 (the "Original Trademark Agreement");

WHEREAS, the parties hereto desire to amend and restate the Original Trademark Agreement to, among other things, ensure compliance with applicable copyright, trademark, patent and similar intellectual and industrial property laws and the Grantors' obligations under the Guarantee and Collateral Agreement;

Now, Therefore, in consideration of the premises and other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, the Grantors hereby agree with the Collateral Agent, as follows:

SECTION 1. <u>Defined Terms</u>. Unless otherwise defined herein, capitalized terms have the meaning given to them in the Guarantee and Collateral Agreement.

SECTION 2. <u>Grant and Confirmation of Security Interest in Trademark Collateral.</u>

(a) Each Grantor hereby confirms the grant of a security interest in the Trademark Collateral (as defined below) set forth in the Original Trademark Agreement and the Guarantee and Collateral Agreement as of the date of such agreements and does

further hereby grant to the Collateral Agent for the ratable benefit of the Secured Parties, as of the date hereof, a security interest in all the following property of such Grantor, in each case, wherever located and now owned or at any time hereafter acquired by such Grantor or in which such Grantor has or at any time in the future may acquire any right, title and interest (collectively, the "<u>Trademark Collateral</u>"), as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration, or otherwise) of such Grantor's Obligations:

- (i) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos, designs and other source or business identifiers, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof or any other country, union of countries, or any political subdivision of any of the foregoing, or otherwise, and all common-law rights related thereto, including any of the foregoing listed on Schedule I hereto,
 - (ii) the right to, and to obtain, all renewals thereof,
- (iii) the goodwill of the business connected with the use of and symbolized by the foregoing,
 - (iv) general intangibles of a like nature and
- (v) the right to sue for past, present and future infringements or dilution of any of the foregoing or for any injury to goodwill, and all proceeds of the foregoing, including royalties, income, payments, claims, damages and proceeds of suit;
- provided that notwithstanding any other provision set forth in this Section 2, this Trademark Security Agreement shall not, at any time, constitute a grant of a security interest in any property that is, at such time: (i) an Excluded Asset or (ii) an application to register a Trademark in the U.S. Patent and Trademark Office based on a Grantor's "intent to use" such Trademark, provided that at such time a Statement of Use or Amendment to Allege Use is filed therein such Trademark application shall be considered automatically included in the Trademark Collateral.
- (b) Notwithstanding anything herein to the contrary, (i) each Grantor shall remain liable for all obligations under and in respect of the Trademark Collateral and nothing contained herein is intended or shall be a delegation of duties to the Collateral Agent or any other Secured Party, (ii) each Grantor shall remain liable under and each of the agreements included in the Trademark Collateral, including any Receivables, any Contracts and any agreements relating to Pledged Partnership Interests or Pledged LLC Interests, to perform all of the obligations undertaken by it thereunder all in accordance with and pursuant to the terms and provisions thereof and neither the Collateral Agent nor any other Secured Party shall have any obligation or liability under any of such agreements by reason of or arising out of this Trademark Security Agreement or any other document related hereto nor shall the Collateral Agent nor any other Secured Party have any obligation to make any inquiry as to the nature or sufficiency of any

payment received by it or have any obligation to take any action to collect or enforce any rights under any agreement included in the Trademark Collateral, including any agreements relating to any Receivables, any Contracts or any agreements relating to Pledged Partnership Interests or Pledged LLC Interests and (iii) the exercise by the Collateral Agent of any of its rights hereunder shall not release any Grantor from any of its duties or obligations under the contracts and agreements included in the Trademark Collateral, including any agreements relating to any Receivables, any Contracts and any agreements relating to Pledged Partnership Interests or Pledged LLC Interests.

SECTION 3. Security Agreement. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Collateral Agent for the Secured Parties pursuant to the Guarantee and Collateral Agreement and Grantors hereby acknowledge and affirm that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Guarantee and Collateral Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to conflict with the Guarantee and Collateral Agreement, the provisions of the Guarantee and Collateral Agreement shall control.

SECTION 4. <u>Filings Fees.</u> Grantors hereby agree to provide Latham & Watkins LLP payment of the filing fees and expenses incurred in connection with the filing of this Agreement and shall reimburse Latham & Watkins for any additional out-of-pocket expenses in connection therewith.

SECTION 5. <u>Applicable Law</u>. This Trademark Security Agreement shall be construed in accordance with and governed by, the laws of the State of New York.

SECTION 6. <u>Counterparts</u>. This Trademark Security Agreement may be executed by one or more of the parties to this Trademark Security Agreement on any number of separate counterparts (including by facsimile) and all of said counterparts together shall be deemed to constitute one and the same instrument.
