TRADEMARK ASSIGNMENT



Isotec further covenants and agrees that it will at any time, upon the request of World Factory, execute and deliver any and all papers and do all lawful acts that may be necessary or desirable to perfect the title to, and enforce, said trademark, registration, and application.
