ASSIGNMENT AND ASSUMPTION AGREEMENT

THIS ASSIGNMENT AND ASSUMPTION AGREEMENT ("Assignment") is entered into effective May 31, 2005, by and between Official Starter LLC ("Assignor"), a Delaware limited liability corporation and NIKE, Inc. ("Assignee"), an Oregon corporation.

RECITALS

- A. WHEREAS Assignor is the owner of certain trademarks and other intellectual property associated with the Starter brand;
- B. Whereas Assignor is dissolving pursuant to a Plan of Dissolution effective May 31, 2005 (the "Plan"), such Plan having been approved by the sole member and all of the managers of Assignee.
- C. Whereas, pursuant to said Plan, Assignor wishes to assign to Assignee all rights, title and interest in the trademarks and other intellectual property associated with the Starter brand;
- D. Whereas Assignee agrees to accept such assets;

NOW, THEREFORE, the parties agree as follows:

1. Assets. Assignor, pursuant to the Plan, does hereby transfer, convey and assign to Assignee at 12.01 AM on June 1, 2005 (the "Effective Date"), and Assignee hereby acquires from Assignor as of the Effective Date, all of Assignor's right, title and interest in and to the assets specified in this Section 1 (collectively the "Transferred Assets"):

- (a) All of the trademark rights identified in Schedule 1 hereto and any and all other trademark rights owned by Assignor but not specifically listed, including without limitation all trademark registrations, trademark applications and any renewals relating thereto and all of the goodwill symbolized by and associated with the business conducted under such trademarks (collectively the "Trademarks");
- (b) All rights in any and all trade dress, labels and designs associated with the Trademarks;
- (c) All other intellectual property identified in Schedule 1 thereto;

- (d) All of the internet domain names, URLs and sites identified in Schedule 2 hereto and any and all other domain names, URLs and sites owned by Assignor but not specifically listed.

2. Assignment and Assumption of Causes of Action, Income, Royalties, Obligations and Liabilities. Assignor hereby assigns and Assignee hereby assumes as of the Effective Date the entire right, title and interest in all income, royalties, liabilities, obligations, damages and payments now or hereafter due or payable in respect of the Trademarks and in and to all causes of action, either in law or in equity, administrative or judicial, including but not limited to those actions identified in Schedule 3, for past, present, or future infringement, misappropriation or dilution based on the Trademarks and in and to any and all other rights corresponding to the Trademarks throughout the world.

3. Representation and Warranties of Assignor.

- 3.1. Assignor represents and warrants that it is the sole and lawful owner of all right, title and interest in and to the Transferred Assets, with full right and power to make and consummate this Assignment.
- 3.2. Assignor represents and warrants that it has not assigned, transferred, pledged or otherwise encumbered any of the Transferred Assets or agreed to do so.
- 3.3. Assignor represents and warrants that it has received no claim that any of the Transferred Assets or the exercise, use or practice thereof will infringe or constitute a misappropriation of any of the rights or properties of any third party, nor, to the best of Assignor's knowledge, are there grounds for such a claim.
- 3.4. Assignor represents and warrants that it is not aware of any questions or challenges with respect to the patentability or validity of any claims of any existing patents or patent applications included within the Transferred Assets.
- 3.5. Assignor represents and warrants that it has taken reasonable efforts to maintain the secrecy of the trade secrets included within the Transferred Assets.

4. Execution of Documents. Assignor agrees to execute all documents, papers, forms and authorizations and to perform such other proper acts as Assignee may deem necessary to secure to Assignee or its designee the rights herein assigned.

5. Governing Law. This Assignment shall in all respects be governed by, and construed in accordance with, the laws of the State of Oregon, without regard to conflict of laws principles.


6. Counterparts. This Assignment may be executed in several counterparts, each of which shall be deemed an original, and all such counterparts shall constitute one and the same instrument.

7. Binding Nature. This Assignment shall be binding upon, and inure to the benefit of, the parties hereto and their successors and assigns.

IN WITNESS WHEREOF, the parties hereto have caused this Assignment Agreement to be duly executed and delivered as of the day and year first above written.





CAUSES OF ACTION ASSUMED BY ASSIGNEE

- Russian Federation Application No. 97709559 for "STARTER with S and Star Design" has been refused registration by the Russian Federation Intellectual Property Office based on prior existing registrations, namely, International Registration No. 546578 for INDUSTRIAL STARTER, presumably owned by Industrial Starter S.p.A., and International Registration No. 623178 for STARTER RUGGED TERRAIN and Design, currently owned by Off. Starter Europe S.L. International Registration 623178 has been cancelled for non-use. On July 28, 2004, Donald F. Frei of Wood Herron and Evans, on behalf of Official Starter LLC, instructed Andreas Renck of Lovells, the Spanish associate, to finalize a worldwide co-existence agreement with Industrial Starter S.p.A. and its subsidiaries. On the same date, Mr. Frei also informed Tamara Istomina of Gowlings, Official Starter LLC's Russian Federation associate handling Russian Federation Application No. 97709559, of this potential agreement. In a letter dated August 2, 2004, Ms. Istomina indicated that the deadline to reply to the Russian refusal is September 22, 2004, but that this date may be extended if a co-existence agreement is not entered with Industrial Starter by that time, by filing a non-use cancellation proceeding against International Registration No. 546578. If a co-existence agreement is reached with Industrial Starter S.p.A. and a consent is filed in the Russian Federation application, it is expected that the application will proceed to registration.
