TRADEMARKS AND SERVICE MARKS**

**WHEREAS**, Fleet Capital Corporation a Rhode Island Corporation having an office at 100 Federal Street, Boston, MA 02110 (the "Assignor"), as agent for itself and other lending institutions which are parties to a Second Amended and Restated Credit and Security Agreement, dated as of January 2, 2004 (as amended and in effect from time to time, the "Credit Agreement"), among Columbus McKinnon Corporation (the "Company"), the Assignor and certain other parties named therein, is the holder of a security interest in the trademarks, trade names, trade dress, service marks and other indicia of trade origin (and the goodwill associated therewith) identified on Exhibit A hereto (collectively, the "Marks") and in the registrations of and pending registration applications for such Marks in the United States Patent and Trademark Office ("PTO") identified on said Exhibit A pursuant to an Intellectual Property Security Agreement, dated as of March 31, 1998, between the Company and the Subsidiary Grantors named therein (collectively, the "Grantors") and the Assignor and pursuant to a Trademark Collateral Security and Pledge Agreement, dated as of November 21, 2002 by and among the Company, Yale Industrial Products, Inc. and the Assignor;

**WHEREAS**, Bank of America, N.A., a National Banking Association having an office at 901 Main Street, Dallas, Texas, 75202 (the "Assignee"), as agent for itself and other lending institutions which are, or may in the future become, parties to the Credit Agreement, is desirous of acquiring the security interest in the Marks (and associated goodwill) and the registrations thereof and registration applications therefor;

**WHEREAS**, concurrently with the execution and delivery of this Assignment, the Borrower, the Candian Borrowers, the Guarantors party thereto, the Lenders party thereto and Administrative Agent are entering into a First Amendment to that certain Second and Amended and Restated Credit and Security Agreement, dated as of April 29, 2005 (as modified, supplemented and restated from time to time, the "Amendment");

**NOW, THEREFORE**, for good and valuable consideration, receipt of which is hereby acknowledged, as of April 29, 2005, the Assignor does hereby assign, sell and transfer to the Assignee, all of the Assignor's security interest in and to the Marks, together with (a) the registrations of and registration applications for the Marks, (b) the goodwill of the business connected with the use of, and symbolized by, the Marks and the registrations thereof, and (c) the right to sue and recover for, and the right to incomes, royalties, damages and other payments now and hereafter due or accrued and arising out of or in connection with, any and all past, present or future infringements, misappropriations or dilution of or damage or injury to the Marks or the registrations thereof or such associated goodwill and (iii) all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of the Grantors accruing thereunder or pertaining thereto.
