

## ASSIGNMENT OF TRADEMARKS

Assignor agrees that it will execute all documents and take all other actions that may be necessary for securing, completing, or vesting in Assignee, its successors and assigns full right, title and interest in the Trademarks and registrations thereof.

Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment shall be governed by and construed in accordance with the laws of the State of Ohio without giving effect to the principles of conflicts of laws thereof.
