

3. The amendment was adopted as of February 28, 2005.

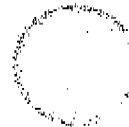
