WHEREAS, pursuant to the Security Agreements, Releasees granted to Releasor a continuing security interest in its right, title and interest in and to the patents and patent

applications, and trademark registrations and applications, listed on Exhibit A attached hereto and made a part hereof (the "Secured Collateral").


NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, Releasor in its capacity as arranger and administrative agent for the Lenders (as defined in the Loan Agreement), hereby unconditionally and expressly releases and terminates its security interest in and to the Secured Collateral, and Releasor hereby assigns any such right, title and interest it may have in the Secured Collateral (if any) to Releasee. This Release shall be binding upon Releasor's legal representatives, assigns and successors. Nothing in this Release shall be deemed a representation or warranty with respect to the Secured Collateral, Releasee's or Releasor's right, title or interest therein or thereto, or the release granted herein, and neither Releasee nor any third party shall have recourse against Releasor in any way in connection with this Release.
