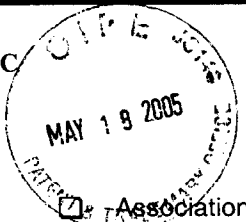

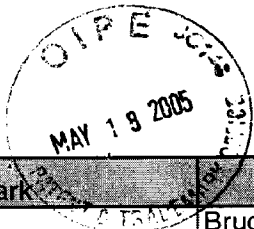

Pursuant to Section 48-21-107 of the Tennessee Business Corporation Act (the "Act"), the undersigned entities, executed the following Articles of Merger:

**FIRST:** Attached hereto and incorporated herein is the Agreement and Plan of Merger by and between Hartco Flooring Company, a Tennessee corporation ("Hartco"), Bruce Hardwood Flooring LLC, a Delaware limited liability company ("Bruce"), and Robbins Hardwood Flooring, Inc., a Delaware corporation ("Robbins") (the "Agreement and Plan of Merger"), whereby Bruce and Robbins will merge with and into Hartco under the terms and conditions set forth therein.

**SECOND:** Pursuant to Section 48-21-105 of the Act, approval of the Agreement and Plan of Merger by the shareholders of the entities is not required because the entities are wholly owned subsidiaries of the same corporation.

**THIRD:** Notwithstanding the provisions of Section 48-21-105 of the Act, the Agreement and Plan of Merger was approved by the sole shareholder of Hartco and Robbins and the sole member of Bruce by written consent in lieu of a meeting on March 24, 2005.

**FOURTH:** The Agreement and Plan of Merger was adopted and approved by the directors of Hartco and Robbins and the managers of Bruce by unanimous written consent in lieu of a meeting on March 24, 2005.

**FIFTH:** The Agreement and Plan of Merger and performance of its terms were duly authorized by all action required under the laws that each constituent entity was organized and by the respective charter, certificate of incorporation or formation, as applicable, of each constituent entity.

**SIXTH:** The merger is to become effective at 11:45 p.m., Eastern Standard Time, on March 31, 2005.
