TRADEMARK ASSIGNMENT

WHEREAS, Lebow Products Inc., a California corporation (the "Assignor"), has adopted and is using or has a bona fide intent to use the trademarks listed in Exhibit A hereto (the "Trademarks"); and

WHEREAS, Honeywell International Inc., a Delaware corporation (the "Assignee"), is a party to that certain Asset Purchase Agreement, dated July 29, 2005, by and among the Assignor, the Assignee, Transducer Controls Corporation, a California corporation, and Tedeo Ltd., an Israeli corporation (the "Purchase Agreement"), and is desirous of acquiring the entire right, title and interest in and to the Marks, all U.S. and foreign applications for registration and/or registrations thereof, all common law rights in and to the Marks and the goodwill pertaining thereto; and

The Assignor hereby sells, assigns and transfers unto Assignee, its successors and assigns, its entire right, title and interest in and to the Trademarks, including any and all common law rights, State, Federal or foreign registrations and/or applications for registration thereof, all trade name rights, service name rights and together with all of the goodwill of the business pertaining to the Trademarks.

The Assignor hereby authorizes Assignee, its successors and assigns, or anyone it may properly designate, to execute, file and deliver such instruments as may be necessary, appropriate or desirable to establish Assignee's record ownership of the Trademarks.

Upon said consideration, Assignor does hereby covenant and agree with Assignee, its successors and assigns, that it will not execute any writing or do any act whatsoever conflicting with these provisions, and that Assignor will at any time upon request, without further or additional consideration, but at the expense of Assignee, its successors and assigns, execute such additional writings and do such additional acts as Assignee, its successors and assigns, may deem necessary or desirable to perfect the Assignee's ownership of the Trademarks, and render all necessary assistance in establishing Assignee's record ownership of the Trademarks.

This Assignment may be executed simultaneously in one or more counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument.

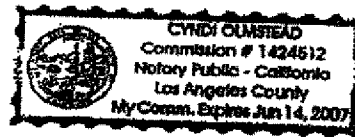

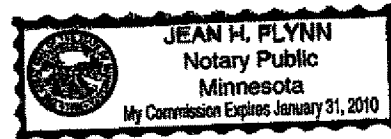
