**RELEASE AND TERMINATION OF SECURITY INTEREST**

**THIS RELEASE** is made effective September 30, 2005, by **Royalty Securitization Trust I**, a statutory trust organized under the laws of Delaware ("RST"), **Deutsche Bank Trust Company Americas**, a New York banking corporation, not in its individual capacity but solely as Indenture Trustee ("DBTC"), **Paul Royalty Fund Holdings II**, a California general partnership, ("PRII" and, together with RST and DBTC, "Secured Parties" and each individually a "Secured Party") for the benefit of **Artery, LLC**, a Delaware limited liability company ("Artery") and **Guilford Pharmaceuticals Inc.**, a Delaware corporation ("Guilford"), their successors and assigns.

**WHEREAS**, PRII, Paul Royalty Fund, L.P., a Delaware limited partnership ("PRF"), Artery, Guilford and GPI Investments, LLC, a Delaware limited liability company formerly known as GPI Holdings, Inc., ("GPI" and, together with Guilford and Artery, "Released Parties" and each individually a "Released Party") are parties to that certain Revenue Interest Assignment Agreement dated as of October 28, 2003 ("RIAA").

**WHEREAS**, PRF has assigned its interest under the RIAA to Royalty Financial Company LLC, which in turn assigned its interest to RST, which in turn pledged its interest to DBTC;

**WHEREAS**, The Secured Parties each hold a Security Interest in and to certain intellectual properties owned or licensed by a Released Party, including, without limitation, the intellectual properties listed on Schedule A, attached hereto (collectively referred to herein as "Intellectual Property Collateral"), arising out of the RIAA and related documents; and

**WHEREAS**, The Secured Parties each wish to release its Security Interest in and to said Intellectual Property Collateral;

**NOW, THEREFORE**, in consideration of the foregoing premises and of other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree, as follows:

1. As of the date of this Release, each Secured Party does hereby terminate and release any lien, claim, encumbrance or interest in and to the Intellectual Property Collateral, which at least includes certain utility patents and trademarks listed in the United States Patent and Trademark Office records at the following Reel/Frame Nos.:



This Release shall be governed by and construed under the laws of the State of New York applicable to contracts made and to be performed entirely within such State, without regard to principles of conflicts of law.
