BILL OF ASSIGNMENT AND ASSUMPTION OF LIABILITIES

THIS BILL OF ASSIGNMENT AND ASSUMPTION OF LIABILITIES ("Agreement"), dated as of this 31st day of May, 1999, is made and entered into by and between Biomet, Inc., an Indiana Corporation (hereinafter the "Company"), and Biomet Manufacturing Corporation, an Indiana Corporation (hereinafter "Biomet Manufacturing Corp.").

The Company hereby covenants and agrees to and with Biomet Manufacturing Corp., and its successors and assigns, to do, execute, acknowledge and deliver, or to cause to be done, executed, acknowledged and delivered, to Biomet Manufacturing Corp., and its successors or assigns, all such further acts, deeds, conveyances, transfers, assignments, powers of attorney and assurances as may reasonably be requested by Biomet Manufacturing Corp. in order to facilitate and evidence the conveyance, transfer, assignment and delivery, or to aid and assist in collecting or reducing to possession, any or all of the Company assets included within the Contribution.

Biomet Manufacturing Corp. hereby covenants and agrees to and with the Company, and its successors and assigns, to do, execute, acknowledge and deliver, or to cause to be done, executed, acknowledged and delivered, to the Company, and its successors or assigns, all such further acts, deeds, assumptions, powers of attorney and assurances as may reasonably be requested by the Company in order to facilitate the assumption by Biomet Manufacturing Corp. of the liabilities of the Company included within the Contribution.

This Agreement shall be binding upon and inure to the benefit of the respective successors and assigns of the Company and Biomet Manufacturing Corp.

IN WITNESS WHEREOF, the Company and Biomet Manufacturing Corp. have caused this Bill of Assignment and Assumption of Liabilities to be duly executed as of the date first above written.
