**INSTRUMENT OF ASSIGNMENT AND ACCEPTANCE  
OF TRADEMARK SECURITY AGREEMENTS**

This INSTRUMENT OF ASSIGNMENT AND ACCEPTANCE dated as of February 18, 2004 (this "Assignment") is between Fleet National Bank, as Administrative Agent ("Fleet"), and Canadian Imperial Bank of Commerce, as successor Administrative Agent ("CIBC").

**WITNESSETH:**

WHEREAS, Fleet was the original administrative agent under that certain Amended and Restated Credit Agreement (the "Credit Agreement") and that certain Senior Secured Floating Rate Note Purchase Agreement (the "Note Purchase Agreement"), each dated as of June 24, 2003, among Affinity Group, Inc. (the "Borrower"), the guarantors party thereto (the "Guarantors"), the lenders and the agents party thereto;

WHEREAS, Fleet was the original grantee under the Collateral Documents (as defined in the Credit Agreement) securing the obligations of the Borrower and the Guarantors under the Credit Agreement and the Note Purchase Agreement;

WHEREAS, on the date hereof, Fleet has resigned as administrative agent;

WHEREAS, on the date hereof, CIBC accepted the appointment as administrative agent;

WHEREAS, CIBC, as successor administrative agent, succeeded to the properties, interests, rights, powers, and duties of Fleet as administrative agent in, to and under the Collateral Documents;

NOW, THEREFORE, in consideration of the premises and mutual agreements herein contained and other good and valuable consideration, receipt of which is hereby acknowledged, the parties hereto agree as follows:

1. Fleet, in its capacity as administrative agent, hereby assigns and transfers irrevocably to CIBC, in its capacity as administrative agent and as grantee under that certain Trademark Security Agreement dated as of April 2, 1997 (the "1997 Trademark Agreement") and that certain Amended and Restated Trademark Security Agreement dated as of June 24, 2003 (the "2003 Trademark Agreement") and its successors and assigns, all the properties, rights, powers and duties of Fleet in, to and under the 1997 Trademark Agreement and the 2003 Trademark Agreement, and the security interest in all trademarks, service marks, common law trademarks and trade names of each Debtor party to the 1997 Trademark Agreement or the 2003 Trademark Agreement, either owned by or assigned to such Debtor, including with out limitation the registrations, applications, unregistered trademarks and service marks set forth on Schedule I attached hereto.

2. CIBC hereby accepts such assignment and accepts all the properties, rights, powers and duties of Fleet under and pursuant to the 1997 Trademark Agreement and the 2003 Trademark Agreement, and the security interest in all trademarks, service marks, common law trademarks and trade names of each Debtor party to the 1997 Trademark Agreement or the 2003 Trademark Agreement, either owned by or assigned to such Debtor, including with out limitation

the registrations, applications, unregistered trademarks and service marks set forth on Schedule I attached hereto.

3. Fleet will, at the expense of the Credit Parties and at any time and from time to time, promptly execute and deliver all further instruments and documents, and take all further action, that may be necessary or desirable, or that CIBC may reasonably request, in order to transfer any of the properties, rights, powers and duties granted or purported to be granted hereby or to enable CIBC to exercise and enforce its rights and remedies under the 1997 Trademark Agreement and the 2003 Trademark Agreement.

4. This Assignment shall in all respects be governed by, and construed in accordance with, the law of the State of New York, including all matters of construction, validity and performance.

5. This Assignment may be executed in counterparts, each of which when executed and delivered shall be deemed an original, and all such counterparts shall constitute one and the same instrument.


