## ASSIGNMENT OF SECURITY DOCUMENTS

THIS ASSIGNMENT dated as of December 2, 2005, by Old National Bank, a national banking association ("Old National"), as Collateral Agent under each of the Security Documents (as defined below)

### RECITALS:

A Red Spot Paint & Varnish Co, Inc. ("Borrower"), Red Spot Canada Ltd, (the "Guarantor"), certain institutions from time to time parties thereto as Banks, Old National Bank, as Collateral Agent and Comerica Bank as Administrative Agent entered into a Credit Agreement dated as of September 29, 2000, as amended (the "Credit Agreement")

B Pursuant to the Credit Agreement, Borrower and the Guarantor executed and delivered the Security Documents to Old National for the benefit of the Banks under the Credit Agreement

C Old National has resigned as Collateral Agent under the Credit Agreement and Comerica Bank ("Comerica") has been appointed successor Collateral Agent under the Credit Agreement

NOW, IHEREFORE, Old National hereby assigns to Comerica, as successor Collateral Agent under the Credit Agreement, all of its right, title and interest as Collateral Agent in and to each of the following documents (collectively, the "Security Documents"):


- (i) Security Agreement dated as of September 29, 2000, between Borrower and Old National;

- (x) Three (3) Promissory Notes from Old National Trust Company, as Trustee of the Charles D Storms Irrevocable Joint Insurance Trust established pursuant to the trust agreement dated October 25, 1993 to Red Spot Paint & Varnish Co, Inc, each dated July 22, 2005 in the amounts of \$59,445.29, \$1,523,947.00 and \$22,443.62, each of which are secured by a pledge and collateral assignment of the Northwestern Mutual Life Insurance Policy No. 12 746 244 dated February 18, 1994
