## **TRADEMARK SECURITY AGREEMENT TERMINATION AND RELEASE**

THIS TRADEMARK SECURITY AGREEMENT TERMINATION AND RELEASE (this "Release") is made as of December 7, 2005 ("Effective Date") by THE BANK OF NEW YORK, in its capacity as Administrative Agent for the Lenders (as defined below) ("Grantee") in favor of NEW WORLD PASTA COMPANY, a Delaware corporation ("Grantor").

WHEREAS, Grantor and Grantee are parties to that certain Credit Agreement dated as of January 28, 1999 (as amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the "Credit Agreement") by and among Grantor, the various financial institutions party thereto as lenders (the "Lenders"), the various financial institutions party thereto as co-agents (collectively, the "Co-Agents") for the Lenders, Morgan Stanley Senior Funding, Inc., as syndication agent (the "Syndication Agent") and The Bank of Nova Scotia (as predecessor in interest to Grantee), as Administrative Agent for the Lenders;

WHEREAS, pursuant to the terms and conditions of the Credit Agreement, Grantor and Grantee are parties to that certain Trademark Security Agreement dated as of January 28, 1999 (as amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the "Trademark Security Agreement") between Grantor and The Bank of Nova Scotia (as predecessor in interest to Grantee), whereby Grantor assigned, transferred and conveyed to Grantee, and granted to Grantee, a security interest and mortgage in all of Grantor's right, title and interest in and to the trademark registrations and applications listed in Schedule A hereto (collectively, the "Trademark Collateral");

WHEREAS, The Bank of Nova Scotia resigned as administrative agent for the Lenders under the Credit Agreement and the Trademark Security Agreement and Grantee was appointed as the Administrative Agent for the Lenders under the Credit Agreement and the Trademark Security Agreement;

WHEREAS, the Trademark Security Agreement was originally recorded with the United States Patent and Trademark Office on January 28, 1999 at Reel 1801, Frame 0257 and amended and restated throughout the years, which was subsequently recorded on August 16, 2001 at Reel 2360, Frame 0395, on December 2, 2002 at Reel 2623, Frame 0111, on May 7, 2004 at Reel 2844, Frame 0464 and Reel 2844, Frame 3555 and the assignment of the Trademark Security Agreement to Grantee was recorded with the United States Patent and Trademark Office on September 13, 2004 at Reel 2934, Frame 0830, Reel 2934, Frame 0948, Reel 2934, Frame 795 and Reel 2934, Frame 0860; and

WHEREAS, Grantee desires to terminate the Trademark Security Agreement and release its security interest in the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. The Trademark Security Agreement and Grantee's security interest in the Trademark Collateral (including, without limitation, the trademark registrations listed in Schedule A hereto) is hereby terminated and released.

2. Grantee hereby assigns, transfers and conveys to Grantor, all of Grantee's right, title and interest, now owned or hereafter acquired, that it may have whether by assignment or otherwise, in and to any mortgage and continuing security interest and collateral assignment in the Trademark Collateral, including, without limitation, the entire right, title and interest in and to the trademark applications and trademark registrations listed in Schedule A hereto, including without limitation, all renewals thereof, all proceeds of infringement suits, the right to sue for past, present and future infringements, and all rights corresponding thereto throughout the world and the goodwill related thereto.

3. Grantee represents and warrants that it has the full power and authority to execute this Release and to release its security interest in the Trademark Collateral.

4. Grantee represents and warrants that it has not assigned or otherwise encumbered its security interest in the Trademark Collateral.

5. Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further action as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release.
