WHEREAS, Agent and ANDA, INC., ANDRX CORPORATION, ANDRX LABS, LLC, ANDRX LABORATORIES, INC., ANDRX LABS, INC., ANDRX PHARMACEUTICALS, LLC, CYBEAR, LLC, and MEDICONSULT.COM, INC., (collectively, "Grantors," and each, individually, a "Grantor"), entered into that certain Patent and Trademark Security Agreement dated as of December 30, 2002 (the "Patent and Trademark Security Agreement"; the capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to them in the Patent and Trademark Security Agreement), pursuant to which Grantors granted a security interest to the Agent in, among other things, Trademarks set forth on Schedule 1 attached hereto; and

WHEREAS, the Agent and ANDA, INC., ANDRX LABS, LLC, ANDRX PHARMACEUTICALS, LLC, have entered into a Supplemental Patent and Trademark Security Agreement dated as of November 7, 2003 ("the "Supplemental Agreement"), pursuant to which a security interest to the Agent in, among other things, the Trademarks set forth on Schedule 2 attached hereto; and
