**RELEASE OF SECURITY INTERESTS  
IN TRADEMARK RIGHTS**

RELEASE dated as of November 30<sup>th</sup>, 2005, from JPMorgan Chase Bank, N.A. (formerly known as The Chase Manhattan Bank and JP Morgan Chase Bank), a national banking association, as Administrative Agent (the "Agent") for certain banks and other financial institutions (the "Lenders"), to Seagate Technology, LLC, a Delaware limited liability company (the "Obligor").

WITNESSETH:

WHEREAS, pursuant to certain financing arrangements between the Lenders and the Obligor, prior security interests were granted by the Obligor to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined); and

WHEREAS, the Agent now desires to terminate and release the entirety of its prior security interests in the Trademark Collateral and to have that release recorded at the United States Patent and Trademark Office;

NOW, THEREFORE, for good and valuable consideration the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Obligor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.
2. Release of Security Interest. The Agent hereby terminates, releases and discharges its prior security interests in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.
3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of Agent's prior security interests in the Trademark Collateral contemplated hereby.
4. Purpose of this Release. The purpose of this Release is to record the release by the Agent of all of its prior security interests in the Trademark Collateral. This Release incorporates by reference the terms of (i) the Credit Agreement dated as of May 13, 2002 (as heretofore assumed, amended, supplemented, or otherwise modified from time to time) among Seagate Technology Holdings, a Cayman Islands exempted limited liability company, Seagate Technology HDD Holdings, a Cayman Islands exempted limited liability company, Seagate Technology (US) Holdings, Inc., a Delaware corporation, the Lenders party thereto and the Agent and any related or ancillary documents and letters related thereto; and (ii) the Credit Agreement dated as of November 22, 2005 (as heretofore assumed, amended, supplemented, or

otherwise modified from time to time) among Seagate Technology, a Cayman Islands exempted limited liability company, Seagate Technology HDD Holdings, a Cayman Islands exempted limited liability company, the Lenders party thereto and the Agent and any related or ancillary documents and letters related thereto.

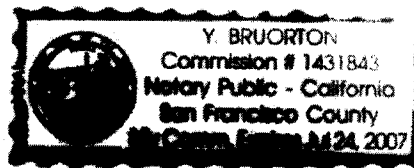
