RELEASE OF SECURITY INTEREST
IN TRADEMARKS

FUNNOODLE, INC., a Delaware corporation, GO FLY A KITE, INC., a Delaware corporation, MAXVERSE INTERACTIVE, INC., a Delaware corporation and TOYMAX, INC., a New York corporation (collectively, the "Grantors"), executed a First Amendment to Trademark Security Agreement dated as of June 21, 2002 in favor of BANK OF AMERICA, N.A., as Administrative Agent ("Agent") for the Lenders ("Lenders") who are a party to that certain Loan Agreement dated as of October 12, 2001 among Jakks Pacific, Inc., a Delaware corporation, Flying Colors Toys, Inc., a Michigan corporation, Road Champs, Inc., a Delaware corporation, Pentech International, Inc., a Delaware corporation, Agent and the Lenders, as it may be amended or modified from time to time, which First Amendment to Trademark Security Agreement was duly recorded on August 9, 2002, at Trademark Reel 002551, Frame 0313, in the United States Patent and Trademark Office, and pursuant to which the Grantors assigned and granted to Agent for the benefit of the Lenders a security interest in and to all of Grantors' right, title and interest in and to certain trademarks and trademark applications, including those trademarks and/or trademark applications specifically listed on Exhibit A attached hereto (the "Released Marks") and the goodwill associated therewith. For good and valuable consideration, receipt of which is hereby acknowledged, Agent hereby releases, retransfers and reassigns to Grantors, without representation or warranty of any kind, express or implied, all of Agent's and Lenders' right, title and interest in and to the Released Marks and the goodwill associated therewith.


