
DECLARATION

I, Rolf Herken, declare that (i) I am President, CEO and CTO of mental images GmbH, with offices at Fasanenstrasse 81, D 10623 Berlin, Germany, (ii) I am authorized to make this declaration on behalf of said company, and (iii) the statements below were made with the knowledge that willful false statements and the like are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code.

On October 1, 2003, the company "Mental Images Gesellschaft für Computerfilm und Maschinenintelligenz mbH & Co. Hard- und Software-Herstellungs- und Entwicklungs KG" (also legally known in the abbreviated form "mental images G.m.b.H. & Co. KG") merged, with a transfer of all rights and properties, with and into "mental images GmbH" ("mental images GmbH"). The company Mental Images Gesellschaft für Computerfilm und Maschinenintelligenz mbH & Co. Hard- und Software-Herstellungs- und Entwicklungs KG (mental images G.m.b.H. & Co. KG) no longer exists, and all rights and interests, including intellectual property, trademarks, and patents, and all the goodwill associated therewith, as well as all other legal property of Mental Images Gesellschaft für Computerfilm und Maschinenintelligenz mbH & Co. Hard- und Software-Herstellungs- und Entwicklungs KG (mental images G.m.b.H. & Co. KG), were transferred as an operation of law to the company mental images GmbH. The company, formerly known as Mental Images Gesellschaft für Computerfilm und Maschinenintelligenz mbH & Co. Hard- und Software-Herstellungs- und Entwicklungs KG and mental images G.m.b.H. & Co. KG, is now known and is registered with the Amtsgericht (local court) in Berlin-Charlottenburg, Germany, as mental images GmbH.

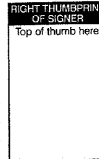
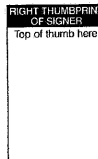


