AMENDED AND RESTATED SECURITY AGREEMENT (COPYRIGHTS AND TRADEMARKS)

AMENDED AND RESTATED SECURITY AGREEMENT (COPYRIGHTS AND TRADEMARKS) dated as of February 7, 2006 (this "Agreement"), by and between FOOTSTAR CORPORATION, a Texas corporation (the "Grantor"), and BANK OF AMERICA, N.A. (successor in interest to Fleet Retail Group, Inc. f/k/a Fleet Retail Finance Inc.), a national banking association, as collateral agent (in such capacity, the "Collateral Agent"), in consideration of the mutual covenants contained herein and benefits to be derived herefrom.

WITNESSETH:

WHEREAS, the Grantor and Footstar, Inc., a Delaware corporation (the "Company", and together with the Grantor, the "Borrowers"), entered into a Debtor-In-Possession Credit Agreement dated as of March 4, 2004 (as amended, the "DIP Credit Agreement") with Bank of America, N.A. (successor in interest by merger to Fleet National Bank), as administrative agent and swingline lender (the "Administrative Agent"), the Collateral Agent (the Administrative Agent and the Collateral Agent are collectively referred to herein as the "Agents"), General Electric Capital Corporation, as syndication agent (in such capacity, the "Syndication Agent") and certain other financial institutions, pursuant to which such financial institutions agreed to make extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein; and

WHEREAS, the DIP Credit Agreement was amended and restated in its entirety pursuant to a certain Amended and Restated Debtor-In-Possession Credit Agreement dated as of May 11, 2004 (as amended, the "<u>First Amended</u> and Restated Credit Agreement"); and

WHEREAS, the First Amended and Restated Credit Agreement was amended and restated in its entirety pursuant to a certain Amended and Restated Debtor-In-Possession and Exit Credit Agreement dated as of June 25, 2004 (as amended by that certain First Amendment to Amended and Restated Debtor-In-Possession and Exit Credit Agreement dated as of July 1, 2005 and that certain Second Amendment to Amended and Restated Debtor-In-Possession and Exit Credit Agreement dated as of November 18, 2005, as amended and in effect as of the date hereof, the "Existing Credit Agreement"); and

WHEREAS, in connection with the DIP Credit Agreement, certain of the Borrowers and the Collateral Agent entered to (i) a Security Agreement dated as of March 4, 2004 (as amended and in effect as of the date hereof, the "Existing Borrower Security Agreement"), pursuant to which the Borrowers granted liens on and security interests in and to all or substantially all of their assets in order to secure the payment and performance of the Borrowers' Obligations under the DIP Credit Agreement, as amended and restated by the First Amended and Restated Credit Agreement, as further amended and restated by the Existing Credit Agreement; and (ii) a Security Agreement (Trademarks) dated as of March 4, 2004 (as amended and in effect as of the date hereof, the "Existing Trademark Security Agreement"), pursuant to which the Grantor granted a lien on and security interest in and to all or substantially all of its intellectual property interests in

order to secure the payment and performance in full of all the Borrowers' Obligations under and as defined in the DIP Credit Agreement, as amended and restated by the First Amended and Restated Credit Agreement, as further amended and restated by the Existing Credit Agreement; and

WHEREAS, the Borrowers have requested, among other things, that the Existing Credit Agreement be amended and restated on the terms and conditions set forth in that certain Amended and Restated Exit Credit Agreement of even date herewith (the "<u>Credit Agreement</u>"), among the Borrowers, the Agents, the Lenders party thereto, and the Syndication Agent; and

WHEREAS, it is a condition precedent to the Credit Agreement, that the Borrowers and the Collateral Agent amend and restate the Existing Borrower Security Agreement in its entirety by entering into the Amended, Restated and Consolidated Security Agreement dated as of February 7, 2006 (as amended, modified, supplemented and restated from time to time, the "Security Agreement"), pursuant to which the Borrowers shall confirm their grant of a lien on and a security interest in and to all or substantially all of their assets in order to secure the payment and performance of the Borrowers' Obligations under the Credit Agreement; and

WHEREAS, it is a further condition precedent to the Credit Agreement, that the Grantor and the Collateral Agent amend and restate the Existing Trademark Security Agreement in its entirety by entering into this Agreement, pursuant to which the Grantor shall confirm its grant of a lien on and a security interest in and to all or substantially all of its intellectual property interests in order to secure the payment and performance of the Borrowers' Obligations under the Credit Agreement; and

WHEREAS, the Grantor is the owner and user of the registered copyrights listed on Schedule A hereto and all copyright rights in, to and under such registered copyrights (collectively referred to herein as the "Copyrights"), and the service marks, trade names and trademarks listed for such Grantor on Schedule A hereto (the "Marks") and the service mark, trade names and trademark applications listed on Schedule A hereto and so identified (collectively, the "Mark Applications"); and

WHEREAS, among the security interests granted by the Grantor to the Collateral Agent pursuant to the Security Agreement is a security interest in the Copyrights, the Marks and the Mark Applications; and

WHEREAS, the parties to the Security Agreement contemplate and intend that, upon the occurrence of any Event of Default, under and as defined in the Credit Agreement, the Collateral Agent shall have all rights of a foreclosing secured party in and to the Copyrights, the Marks and the Mark Applications and any proceeds thereof (including any service marks, trade names and trademarks issued as a result of the Mark Applications), including, without limitation, the right, following such foreclosure, to transfer to a purchaser all of the right, title and interest of the Grantor in and to any of the Copyrights, any of the Marks and any of the Mark Applications (and any service marks, trade names and trademarks issued as a result of any of the Mark Applications); and

WHEREAS, the Grantor and the Agents now wish to amend and restate the Existing Trademark Security Agreement for the benefit of the Lenders and the Agents as herein provided, which amendment and restatement shall supersede in its entirety the Existing Trademark Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties reconfirm the terms of the Security Agreement, as if set forth fully herein, and acknowledge that the Collateral Agent has a security interest in the Copyrights, the Marks and the Mark Applications listed on Schedule A hereto as security for the Obligations; the Grantor hereby collaterally assigns to the Collateral Agent, and grants a security interest to the Collateral Agent in all right, title and interest of the Grantor in and to said Copyrights, the Marks and the Mark Applications (and in any service marks, trade names and trademarks issued as a result of the Mark Applications) and the goodwill associated therewith; the Grantor agrees that it will not sell or assign any of the Copyrights, the Marks or the Mark Applications without the prior written consent of the Collateral Agent except as may be otherwise permitted under the Credit Agreement; and each of the Grantor and the Collateral Agent requests that the U.S. Copyright Office and the Commissioner of Patents and Trademarks record this document with respect to the Copyrights, the Marks and the Mark Applications.

The Grantor hereby appoints the Collateral Agent as its attorney-in-fact (with full power of substitution and resubstitution), coupled with an interest, with the power and authority, after the occurrence of any Event of Default, to execute and deliver, in the name and on behalf of the Grantor, and to cause the recording of all such further assignments and other instruments as the Collateral Agent may reasonably deem necessary or desirable in order to carry out the intent of the Security Agreement and this Agreement. The Grantor agrees that all third parties may conclusively rely on any such further assignment or other instrument, so executed, delivered and recorded by the Collateral Agent (or the Collateral Agent's designee in accordance with the terms hereof) and on the statements made therein.

This Agreement is made for collateral purposes only. This Agreement and the security interest represented hereby shall terminate when all the Obligations have been indefeasibly paid in full in immediately available funds, the Lenders have no further commitment to lend, there are no Letter of Credit Outstandings (or all such Letter of Credit Outstandings are fully cash collateralized in a manner satisfactory to the Issuing Bank) and the Issuing Bank has no further commitment to issue Letters of Credit under the Credit Agreement, at which time, upon the request of the Grantor, the Collateral Agent shall execute and deliver to the Grantor, at the Grantor's expense, all termination statements, releases and similar documents that the Grantor shall reasonably request to evidence such termination and the release of the security interests.

All capitalized terms used but not elsewhere defined in this Agreement shall have the meanings ascribed to such terms in the Credit Agreement, as applicable. Except as expressly provided herein, the rights, remedies and obligations of the parties hereto are governed by the provisions of the Security Agreement, all of which are incorporated herein by reference and made a part hereof.
