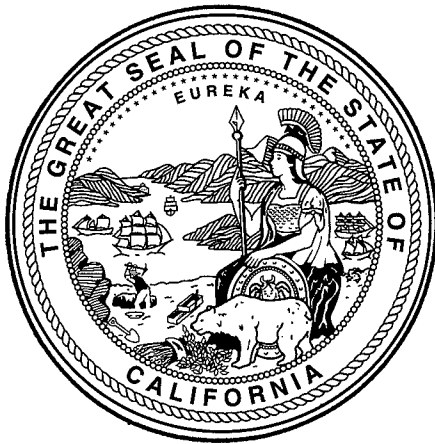

THE AMENDED AND RESTATED ARTICLES OF INCORPORATION OF  
SMARTHOME, INC.

The undersigned certify that:

1. They are the President and the Secretary, respectively, of SmartHome, Inc. (the "Corporation"), a California corporation.

2. Article I of the Amended and Restated Articles of Incorporation of the Corporation is amended to read as follows:

"The name of the corporation shall be SmartLabs, Inc."

3. The foregoing amendment of the Amended and Restated Articles of Incorporation of the Corporation has been duly approved by the Board of Directors of the Corporation.

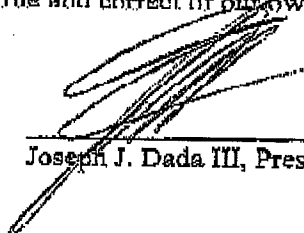
4. The foregoing amendment of the Amended and Restated Articles of Incorporation of the Corporation has been duly approved by the required vote of the shareholders of the Corporation in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares of Common Stock entitled to vote with respect to the amendment is 74,883,375. The total number of outstanding shares of Series A Preferred Stock entitled to vote with respect to the amendment is 10,335,704. The number of shares of each class voting in favor of the foregoing amendment equaled or exceeded the vote required. The percentage vote required was more than 50% of the outstanding shares of Common Stock entitled to vote with respect to the amendment and more than 50% of the outstanding shares of Series A Preferred Stock entitled to vote with respect to the amendment.
