RELEASE OF TRADEMARK SECURITY INTEREST

This Release is granted as of the 21st day of June, 2005, by Citicorp USA, Inc. ("CUSA"), as agent for the Secured Parties (as defined in the Credit Agreement referred to below)(in such capacity, the "Administrative Agent"), to FMC Corporation (the "Borrower") and each of the other entities which is a party to the Trademark Security Agreement referred to below (collectively, the "Grantors"), as follows:

W I T N E S S E T H

WHEREAS, pursuant to the Credit Agreement, dated as of October 21, 2002 (the "Credit Agreement"), among the Borrower, the Lenders and Issuers party thereto and CUSA, as agent for the Lenders and Issuers, and the related Pledge and Security Agreement dated as of October 21, 2002, the Grantors and the Administrative Agent executed and delivered a Trademark Security Agreement dated as of October 21, 2002 (the "Trademark Security Agreement");

WHEREAS, in the Trademark Security Agreement, the Grantors granted a security interest in the Trademark Collateral, as defined therein (the "Trademark Collateral");

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on November 19, 2002 at Reel/Frame No. 2621/0327; and


WHEREAS, Administrative Agent wishes to release and reassign to the Grantors its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Administrative Agent, hereby (1) releases, discharges and relinquishes, as of June 21, 2005, all right title, and interest that it may have had in the Trademark Collateral, including the goodwill associated with the Trademark Collateral, any and all applications or registrations therefor, and the right to sue for past, present and future infringements, and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits. The Administrative Agent specifically acknowledges that the Trademark Security Agreement is no longer effective, and that it does not own any rights to or have any ownership interest in the Trademark Collateral, and all of the rights and remedies with respect to the Trademark Collateral have been and are hereby extinguished.

The Administrative Agent hereby authorizes the Grantors to file this instrument with the United States Patent and Trademark Office at the sole cost and expense of the Grantors.

IN WITNESS WHEREOF, the undersigned, by and through its authorized officer, has caused this instrument to be executed on February 24, 2006, but effective as of the date first written above.
