
## **REPRESENTATION AND WARRANTIES**

Zigann further represents that there are no claims, judgments or settlements to be paid by Zigann or, to the best of Zigann's knowledge,


any pending claims or litigation, by or against Zigann or any prior owner of the Mark, relating to the Mark.
