# ASSIGNMENT OF TRADEMARK RIGHTS

This AGREEMENT, whose effective date is that of the last signature hereon, is by and between:

Frank Industries, Inc. ("ASSIGNOR"), a corporation of Michigan having a place of business at 3950 Burnsline Road, Brown City, Michigan, USA 48416; and

- 2. In that the ASSIGNEE desires to acquire all right, title and interest in and to the above MARKS, and the ASSIGNOR has agreed to such a transfer of their rights in the MARKS through and as a consequence of the purchase by the ASSIGNEE of assets of the ASSIGNOR at auction on or about April 23, 2005, the ASSIGNOR and ASSIGNEE agree to the following:
  - a. In exchange for good and valuable consideration, receipt of which is acknowledged by this AGREEMENT, the ASSIGNOR formally assigns to the ASSIGNEE all right, title and interest, in all countries, in the MARKS;
  - b. By this AGREEMENT, the ASSIGNOR also transfers the goodwill that is connected with the use of and symbolized by the MARKS, including the goodwill of any business in which the MARKS have been used;
  - c. By this AGREEMENT, the ASSIGNOR renounces all goodwill embodied in the MARKS, such that all goodwill arising from the ASSIGNEE's use of the MARKS will inure solely to the benefit of the ASSIGNEE;

- d. The ASSIGNOR shall not adopt or use, without prior written consent from the ASSIGNEE, any variation of the MARKS or any word or mark likely to be similar to or confusingly similar with the MARKS;
- e. The ASSIGNOR shall not take any action that could be detrimental to the goodwill associated with the MARKS; and
- f. As assignee of the MARKS, the ASSIGNEE shall have the right to record this AGREEMENT with the U.S. Patent and Trademark Office, and to secure further registration of the MARKS as the ASSIGNEE deems appropriate. The ASSIGNOR shall cooperate in good faith to provide information in support of the recordation of this AGREEMENT and in support of the filing and prosecution of any trademark application filed by the ASSIGNEE on the MARKS.
- 3. The ASSIGNOR warrants that it is the sole owner of all rights, title and interest in the MARKS, and to have the right to assign such rights, title and interest.
- 4. This AGREEMENT shall be binding on the successors and assignees of the ASSIGNOR and ASSIGNEE.
- 5. This AGREEMENT is executed by duly authorized representatives of the ASSIGNOR and ASSIGNEE.
