#### FIRST AMENDMENT

#### TO

## TRADEMARK, PATENT AND COPYRIGHT SECURITY AGREEMENT

This First Amendment to Trademark, Patent And Copyright Security Agreement (this "Amendment") is made as of this 7th of March, 2006, by and among Simonds Industries Inc., a Delaware corporation ("Simonds"); Armstrong Manufacturing Company, an Oregon corporation ("Armstrong"); Simonds International Corporation, a Delaware corporation; Armstrong Merger Subsidiary, Inc., a Delaware corporation; and Simonds Canada, Ltd., an Ontario corporation; (each a "Borrower" and collectively with Simonds and Armstrong, the "Borrowers") and Citizens Bank of Massachusetts, a Massachusetts bank (hereinafter called the "Bank").

### RECITALS

WHEREAS, Simonds, Armstrong and certain of their affiliates ("Original Borrowers") and Bank are parties to a Loan and Security Agreement (All Assets) dated as of December 29, 2000 (the "Original Credit Agreement");

WHEREAS, in order to secure the payment and performance of the Obligations (as defined in the Original Credit Agreement) the Original Borrowers granted to the Bank under a Trademark, Patent And Copyright Security Agreement dated as of June 19, 2001 (the "IP Security Agreement") a security interest in all their intellectual property as a supplement to the security interests granted in the Original Credit Agreement;

WHEREAS, the Bank has increased the amount of the credit facility and amended the Original Credit Agreement pursuant to a Second Amended And Restated Loan And Security Agreement (All Assets) dated as of December 21, 2005 ("Current Credit Agreement");

WHEREAS, Simonds has registered additional United States Trademarks (as defined in the IP Security Agreement) and United States Patents (as defined in the IP Security Agreement) with the United States Patent and Trademark Office since execution of the IP Security Agreement, which additional United States Trademarks and United States Patents are set forth on Exhibits A and B hereto, respectively;

WHEREAS, the Original Borrowers other than Simonds and Armstrong have been dissolved or merged into one of the Borrowers;

NOW, THEREFORE, the Borrowers hereby agree as follows:

1. Each of the Borrowers joins in the IP Security Agreement and becomes a Debtor thereunder as though an original party to the IP Security Agreement.

- 2. The Borrowers confirm that they have collaterally assigned to the Bank and have granted to the Bank a security interest in the United State Trademarks and United States Patents registered with the United States Patent and Trademark Office set forth on Exhibits A and B hereto.
- 3. This instrument is made as a supplement and amendment to the IP Security Agreement. The Borrowers authorizes the Bank to record this instrument in the United States Patent and Trademark Office, as well as in any other federal or state office in which any of the Borrower's rights or interests comprising or connected with the Collateral have been registered or recorded.
