ASSIGNMENT OF TRADEMARK

WHEREAS, Indy Racing League, LLC, an Indiana limited liability company located at 4565 West 16th Street, Indianapolis, Indiana 46222 ("Assignor"), is the owner of U.S. Application Serial No. 76/403,631 for the mark SAFER in connection with an energy-absorbing vehicle barrier system comprised of polystyrene and metal for vehicle safety (the "Trademark"), together with the goodwill symbolized thereby;

WHEREAS, Motorsports Safety Technology, LLC, an Indiana limited liability company located at 4565 West 16th Street, Indianapolis, Indiana 46222 ("Assignee"), is desirous of acquiring the Trademark, together with the goodwill symbolized thereby; and

WHEREAS, Assignor acknowledges and agrees that it shall not be entitled to receive consideration of any kind whatsoever in exchange for the Trademark, and that it is transferring the Trademark to Assignee as a capital contribution;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Assignor hereby assigns to Assignee all its right, title and interest in and to the Trademark, together with the goodwill of the business associated with or symbolized by the Trademark, and any and all common law rights, world-wide rights and other applications and registrations for the Trademark owned by Assignor, and including the right to sue and collect damages for any past or future infringements of the Trademark; and

2. Assignor shall execute and deliver or shall cause to be executed and delivered all such transfers, assignments, conveyances, powers of attorney, assurances or any other documents necessary to confirm, effectuate or record the assignment granted herein and shall take all such further action, including, without limitation, making all filings with the United States Patent & Trademark Office in order to confirm, effectuate or record this assignment of the Trademark to Assignee granted herein as Assignee may from time to time reasonably request.
