TRADEMARK SECURITY INTEREST RELEASE

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of April 25, 2006, by THE BANK OF NEW YORK, a NEW YORK corporation (hereinafter, the "Bank")

WITNESSETH:

WHEREAS, the Bank and Craft House Corporation, a Michigan corporation (hereinafter, "Craft"), are parties to that certain Trademark Security Agreement dated as of June 13, 1997 (the "Security Agreement"), pursuant to which Craft granted a security interest to the Bank in the Released Trademarks (as such term is defined below) as security for certain obligations owing by Craft; and

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on July 14, 1997, at Reel 1612, Frame 0185; and

WHEREAS, Craft has requested that the Bank release its security interest in the Released Trademarks to Craft.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged:

1. The Bank hereby releases its security interest in all of Craft's right, title and interest in and to all trademarks, registered trademarks, trademark applications, service marks, registered service marks and service mark applications, including, without limitation, the trademarks, registered trademarks, trademark applications, service marks, registered service marks and service mark applications listed on Exhibit A attached hereto and collectively referred to as the "Released Trademarks"; and

2. The Bank hereby reassigns, grants and conveys to Craft, without any representation, recourse or undertaking by the Bank, all of Bank's right, title and interest in and to the Released Trademarks, and the goodwill of Craft's business connected with the use of and symbolized by the Released Trademarks.

IN WITNESS WHEREOF, the Bank has caused this Trademark Release and Reassignment to be duly executed by its duly authorized officer as of the day and year first above written.


