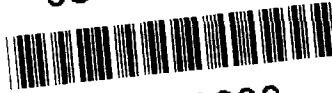


**ASSIGNMENT**
