RELEASE OF
SECURITY INTERESTS IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY (this "Release") is executed this 25th day of May, 2006 by LEHMAN COMMERCIAL PAPER INC., as administrative agent (the "Secured Party").

R E C I T A L S:

A. The Secured Party, Medpointe Healthcare Inc. ("Owner"), the other Loan Parties (as defined therein) and the Lenders (as defined therein) are party to that certain Credit Agreement, dated as of September 28, 2001 (as amended from time to time hereto, the "Credit Agreement"), pursuant to which the Lenders made certain loans and other financial accommodations to Owner (the "Loans").

B. In conjunction with the Credit Agreement, the Loan Parties granted a security interest to Secured Party in (i) certain U.S. federal trademark registrations and applications, including those specified on Schedule A-1 and A-2 attached hereto (the "Trademarks") and (ii) certain U.S. federal patent registrations and applications, including those specified on Schedule B-1 and B-2 attached hereto (the "Patents").

C. The security interest of the Secured Party in the Trademarks listed on Schedule A-1 was recorded in the U.S. Patent and Trademark Office on October 24, 2001, at reel/frame 012530/0854 and the security interest of the Secured Party in the Trademarks listed on Schedule A-2 was recorded in the U.S. Patent and Trademark Office on October 8, 2003, at reel/frame 014567/0804.

D. The security interest of the Secured Party in the Patents listed on Schedule B-1 was recorded in the U.S. Patent and Trademark Office on October 24, 2001, at reel/frame 2423/0001 and the security interest of the Secured Party in the Patents listed on Schedule B-2 was recorded in the U.S. Patent and Trademark Office on October 8, 2003, at reel/frame 2843/0320.

E. The indebtedness arising under the Credit Agreement and secured by the Trademarks and Patents has been satisfied in full and, accordingly, the Secured Party is obligated to release the Trademarks from the liens, security interests, and other rights arising thereunder.

R E L E A S E:

NOW THEREFORE, for good and valuable consideration, the receipt and legal sufficiency of which are acknowledged, Secured Party hereby RELEASES AND FOREVER DISCHARGES any and all liens, security interests, titles, assignments, and other rights against the Trademarks and Patents, arising pursuant to any security agreement or other documents securing the Loans, and hereby RECONVEYS, REASSIGNS, TRANSFERS AND DELIVERS to the Owner all rights with respect to the Trademarks and Patents, and any and all other rights, titles, and interests heretofore assigned and transferred unto the Secured Party pursuant to the Credit Agreement, any security agreement or any other documents securing the Loan. This

Release shall be binding upon Secured Party and Secured Party's successors and assigns and shall inure to the benefit of Owner and Owner's successors and assigns, and any present or future owner of any interest in the Trademarks and Patents.


