ASSIGNMENT OF TRADEMARKS

All rights to the trademarks listed and described on <u>Schedule 5.13(a)(i)</u> to the Asset Purchase Agreement, as attached hereto as <u>Exhibit A</u> including all registrations and applications for registration related to such trademarks (including but not limited to intent to use applications); and
- 2. All accounts, contract or other rights, claims, credits, judgments, remedies, choses in action, rights under express or implied warranties from suppliers, causes of action, rights of recovery, interests in or claims, rebates, refunds or payments from or against vendors, rights of set-off, or rights to sue for past, present or future infringement against third parties and all income, royalties, damages and payments now or hereafter due or payable to the extent arising out of, relating to or in respect of the trademarks listed and described on Schedule 5.13(a)(i) to the Asset Purchase Agreement.

Each Seller hereby covenants and agrees, to the extent legally permissible and consistent with the provisions of the Asset Purchase Agreement, that it will execute and deliver such documents reasonably requested by Purchaser as may be necessary to evidence and effect the sale, assignment, transfer and conveyance of the Trademarks to Purchaser.
