MEMORANDUM OF SUBORDINATION AGREEMENT

THIS MEMORANDUM OF SUBORDINATION AGREEMENT (the "**Memorandum**") is made as of March 14, 2006 by CALIFORNIA KL HOLDINGS, INC., a California corporation, for itself as a subordinated creditor and as administrative agent for all Subordinated Creditors, as defined in the Subordination Agreement referred to below ("**Subordinated Agent**"), with respect to the following:

1. Kids Line, LLC and Sassy, Inc., (collectively, the "**Companies**") are the owners and holders of intellectual property, including but not limited to that listed and more fully described in Exhibit A attached hereto (the "**Property**").

2. Concurrently with the execution of this Memorandum, the Companies have granted to LaSalle Bank National Association ("**Senior Agent**"), as administrative agent, a lien on the Property pursuant to that certain Credit Agreement executed by the Companies, as borrowers, Senior Agent, the other financial institutions party thereto as Lenders and the Syndication Agent and the Documentation Agent (as such terms are defined therein) dated as of the date hereof (the "**Senior Lien**").

3. The Companies have previously granted to Subordinated Agent a lien on the Property pursuant to that certain Subordinated Security Agreement dated as of December 15, 2004, as amended from time to time, by the Russ Berrie and Company, Inc. and its subsidiaries in favor of Subordinated Agent (the "**Subordinated Lien**").

4. Senior Agent and Subordinated Agent have agreed to certain arrangements regarding their relative priorities with respect to payment of the loans secured by the Senior Lien and the Subordinated Lien pursuant to the terms and conditions of that certain Subordination Agreement dated as of the date hereof (the "**Subordination Agreement**") by and among Senior Agent, Subordinated Agent, Michael Levin, Neville Levin, and Joanne Levin.

5. This Memorandum is prepared and executed by the Subordinated Agent for the purpose of evidencing and providing record notice of the Subordination Agreement.

6. In the event of any inconsistency between the terms of the Subordination Agreement and the terms of this Memorandum, the terms of the Subordination Agreement shall prevail. This Memorandum may be executed in any number of counterparts, each of which shall be an original but all of which shall be deemed one and the same document. All terms used but not defined in this Memorandum that are capitalized shall have the meanings given to such terms in the Subordination Agreement.

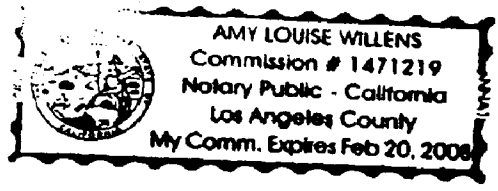
