## ASSIGNMENT AND AMENDMENT OF TRADEMARK SECURITY AGREEMENTS

THIS ASSIGNMENT AND AMENDMENT OF TRADEMARK SECURITY AGREEMENTS (the "Assignment") is made as of this 30th day of June, 2006, between (i) RUSSELL CORPORATION, a Delaware corporation ("Russell"), RUSSELL ASSET MANAGEMENT, INC. a Delaware corporation ("RAM"), and BROOKS SPORTS, INC., a Washington corporation ("Brooks" and, together with Russell and RAM, the "Grantors"), (ii) BANK OF AMERICA, N.A., in its individual capacity as successor to Fleet Capital Corporation, a Rhode Island corporation ("BofA") and (iii) BANK OF AMERICA, N.A., as agent for itself and the other financial institutions from time to time parties to the Loan Agreement (as hereinafter defined) (the "Lenders") (together with its successors and assigns, the "Agent").

### WITNESSETH:

WHEREAS, Russell and certain subsidiaries of Russell (including the other Grantors), as borrowers, the Lenders and BofA are parties to that certain Loan and Security Agreement, dated as of April 18, 2002 (as amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the "Existing Loan Agreement");

WHEREAS, to secure the payment and performance of the obligations under and in connection with the Existing Loan Agreement, (i) Russell executed and delivered to BofA that certain Security Agreement (Trademarks) dated as of April 18, 2002 (the "Russell Trademark Security Agreement"), (ii) RAM executed and delivered to BofA that certain Security Agreement (Trademarks) dated as of April 18, 2002 (the "RAM Trademark Security Agreement") and (iii) Brooks executed and delivered to BofA that certain Security Agreement (Trademarks) dated as of January 31, 2005 (the "Brooks Trademark Security Agreement" and, together with the Russell Trademark Security Agreement and the RAM Trademark Security Agreement, the "Trademark Security Agreements");

WHEREAS, (i) the Russell Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 9, 2002, at Reel 2540, Frame 0094, (ii) the RAM Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 9, 2002, at Reel 2532, Frame 0674 and (iii) the Brooks Trademark Security Agreement was recorded with the United States Patent and Trademark Office on February 9, 2005, at Reel 3024, Frame 0856;

WHEREAS, Russell and certain Subsidiaries of Russell (including the other Grantors), as borrowers, the Agent and the Lenders have agreed to amend and restate the Existing Loan Agreement in its entirety as set forth in that certain Amended and Restated Loan and Security Agreement as of even date herewith (as amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement"; capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed thereto in the Loan Agreement) by and among Russell and certain Subsidiaries of Russell (including the Grantors), as borrowers (the "Borrowers"), the Lenders and the Agent, pursuant to which the Lenders have agreed to extend credit to the Borrowers from time to time pursuant to the terms and conditions thereof;

WHEREAS, BofA has agreed to assign all of its rights and interests under the Trademark Security Agreements to the Agent;

WHEREAS, RAM and the Agent wish to amend the RAM Trademark Security Agreement by adding Trademarks to the Trademark Collateral (as defined in the RAM Trademark Security Agreement); and

WHEREAS, in order to induce the Lenders to enter into the Loan Agreement and the other Loan Documents and to induce the Lenders to extend credit to the Borrowers, as provided in the Loan Agreement, the Grantors have agreed to execute and deliver this Assignment in order to confirm the continuing security interests granted pursuant to the Trademark Security Agreements;

NOW THEREFORE, in consideration of the premises set forth above and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantors hereby agree with BofA and the Agent as follows:

1. Nature of Interest Held by the Agent. The Grantors and BofA hereby agree that the Agent shall hereafter hold all security interests and liens granted under the Trademark Security Agreements, as amended hereby, as the Agent under the Loan Agreement for the benefit of itself and the other Lenders, and BofA does hereby assign and convey unto the Agent all of its right, title and interest in and to the Trademark Security Agreements for such purpose.

2. Obligations Secured. The Grantors agree that the Trademark Security Agreements as modified and amended hereby do now and shall hereafter secure the performance and repayment of the Secured Obligations.

3. Amendments to Trademark Security Agreements. The Grantors and the Agent hereby modify and amend each Trademark Security Agreement as follows:

(a) All references in such Trademark Security Agreement to the "Loan and Security Agreement" and the "Loan Agreement" shall hereafter refer to the Loan Agreement.

(b) All references in such Trademark Security Agreement to the indebtedness or obligations secured thereby shall hereafter refer to the Secured Obligations.

(c) The Trademark Collateral (as defined in the RAM Trademark Security Agreement) listed on Schedule 1 attached hereto shall be and become a part of the Trademark Collateral (as defined in the RAM Trademark Security Agreement) referred to in the RAM Trademark Security Agreement and Schedule A attached thereto and shall secure the Secured Obligations.

4. Re-Affirmation of Grant. To further evidence the foregoing amendments and modifications, each Grantor does hereby reaffirm and again irrevocably pledge, assign and grant to the Agent a continuing security interest in and lien upon all of the Trademark Collateral (as

defined in each Trademark Security Agreement). RAM does hereby grant, assign, transfer, and convey to the Agent continuing security interests in all of RAM's right, title, and interest in, to, and under the Trademark Collateral (as defined in the RAM Trademark Security Agreement) identified on Schedule 1 attached hereto.

5. Governing Law. This Amendment is intended to take effect as a sealed instrument and shall be construed in accordance with and governed by the laws of the State of Georgia, without regard to the conflict of laws principles thereof, except to the extent that the validity or perfection of the security interest hereunder, or remedies hereunder, in respect of any particular Trademark Collateral are governed by the laws of a jurisdiction other than the State of Georgia.

6. Miscellaneous.

(a) Upon the effectiveness of this Assignment, on and after the date hereof each reference in each Trademark Security Agreement to "this Agreement", "hereunder", "hereof" or words of like import referring to such Trademark Security Agreement, and each reference in the other Loan Documents to the "Trademark Security Agreements", "thereunder", "thereof" or words of like import referring to the Trademark Security Agreements, shall mean and be a reference to the Trademark Security Agreements as amended hereby.

(b) This Assignment may be executed in any number of counterparts and by the different parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all of which shall together constitute one and the same instrument. Any signatures delivered by a party by facsimile transmission or by e-mail transmission of an adobe file format document (also known as a PDF file) shall be deemed an original signature hereto. Any party delivering an executed counterpart of this Amendment by facsimile or as a PDF file also shall deliver an original executed counterpart of such agreement but the failure to deliver an original executed counterpart shall not affect the validity, enforceability, and binding effect of this Assignment.

(c) In case any provision in or obligation under this Assignment shall be invalid, illegal or unenforceable in any jurisdiction, the validity, legality and enforceability of the remaining provisions or obligations, or of such provision or obligation in any other jurisdiction, shall not in any way be affected or impaired thereby.

(d) The headings of this Assignment are inserted for convenience only and shall not in any way affect the meaning or construction of any provision of this Assignment.

(e) The pronouns used herein shall include, when appropriate, either gender and both singular and plural, and the grammatical construction of sentences shall conform thereto.


(f) This Assignment shall be deemed to be a Loan Document for all purposes.

(g) The Grantors and the Agent acknowledge and agree that this Assignment shall not constitute a novation of any Trademark Security Agreement.


