

IN CONSIDERATION of the sum of One (\$1.00) Dollar in the hand paid to Conveyor by Receiver, the receipt of which is hereby acknowledged, and for other good and valuable considerations, the parties hereby by agree as follows:


- 1) (a) Conveyor hereby confirms that it is the sole, exclusive owner of the Principal Register Trademark SLAVE serial number 78149038 ("The Mark")

(b) Conveyor does hereby bargain, sell, assign, set over and transfer unto Receiver an Undivided Fifty (50%) per cent interest in The Mark (and all extensions and renewals thereof and all rights and interests incidents thereto in The Mark.
- 2) The Term of this Agreement shall commence on the date hereof and shall terminate upon upon the expiration or termination of The Mark.
- 3) Conveyor hereby grants to Receiver the sole, exclusive and unrestricted right to administer and exploit The Mark by any and all means throughout the world.
- 4) Any and all revenue, income and sums derived from all uses of The Mark shall be divided between Conveyor and Receiver.
- 5) Receiver shall have the sole right for the duration of The Mark (and all extensions and renewals thereof) in its discretion to prosecute, defend, settle and compromise all suits and actions respecting The Mark, and generally to do and perform all things necessary concerning the same and the Trademark therein, to prevent and restrain the infringement of Trademark or other rights with respect to The Mark.
- 6) Conveyor hereby warrants and represents that Conveyor has the full right, power and authority to enter into and perform this Agreement.
- 7) Receiver agrees to and does hereby indemnify, save, and hold Conveyor harmless from any and all loss and damage (including reasonable attorneys' fees) arising out of or connected with any claim by breach or threatened breach by Receiver.



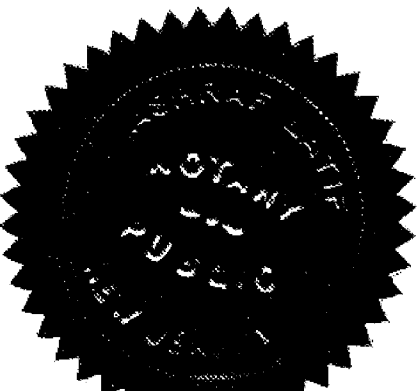
